#### **CITY COUNCIL REGULAR MEETING**

#### **APRIL 6, 2010**

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on April 6, 2010 at 5:30 p.m.

Director of Engineering Jack Carr presented the changes regarding the concerns discussed at the public hearing held on March 30, 2010 for the reconstruction of Industrial Boulevard. Mr. Carr stated that the proposed changes for the turn lanes and partial grass medians will provide for a safer access for truck traffic accessing the industrial businesses. Mayor Pro-Tem Huff asked Mr. Bill Cox if the concerns of the business owners had been addressed with the new proposal. Mr. Cox confirmed that the concerns have been addressed. Council unanimously approved the motion by Mayor Pro-Tem Huff, seconded by Council member Brooks, to approve the Resolution supporting the Texas Department of Transportation Project related to the reconstruction of the State maintained portion of Industrial Boulevard with the agreed upon changes presented at the meeting tonight. 10-135 Mayor Loughmiller called for Public Hearing for а Consideration/Discussion/Action on an Application Submitted by G.H. Sports Group Requesting Six Hundred Thousand Dollars For Construction of an Eight Field Sports Complex and Clubhouse. McKinney Community Development Corporation (MCDC) Board member Tracy Rath stated that this application was approved at their board meeting held on January 28, 2010. The applicant representative, Gordon Hill answered questions from Council. Mr. Hill stated the application does include public access and use of the restrooms. Mr. Hill also said that the bank financing is contingent upon the City Council's approval. Council member Ricchi clarified that the \$300,000 loan and the \$300,000 grant would not be paid until the project was completed and a Certificate of Occupancy was in place. Council member Brooks said he would not like to act on this request until a payment structure and terms of the loan were provided to Council. Council member Kever suggested sending it back to MCDC to bring forward more detail information regarding the loan terms. MCDC Chair Ray Eckenrode stated that the City Attorney's office had offered to G.H. Sports Group the interest rate of prime +1 which is in line with projects that the McKinney Economic Development Corporation funded. Mr. Hill stated that they would agree to this rate. Mayor Loughmiller called for public comments.

Council approved the motion by Council member Day, seconded by Council member Ussery, to close the public hearing and approve the request from G.H. Sports Group for six hundred thousand dollars for construction of an eight field sports complex and clubhouse subject to the McKinney Community Development Corporation working out the details with a vote of 5-2-0, with Council members Kever and Brooks voting against.

Mayor Loughmiller called for Council and City Manager comments.

Council member Ricchi complimented the Public Safety department and the Streets Department for their outstanding work for the City. Mr. Ricchi invited everyone to attend the 2nd Saturday Art Walk on April 10<sup>th</sup> at McKinney Performing Arts Center (MPAC) and throughout the Square. Mr. Ricchi announced that Relay for Life will be held on April 30<sup>th</sup> at the Ballfields at Craig Ranch. The Stonebridge Ranch Ladies Association will have their meeting at MPAC on Monday evening at 7:00 p.m. and will talk about Chestnut Square. Mr. Ricchi commented that the Samaritan Inn received 11 new residents that needed a place to live. Three residents have graduated by finding a job and providing for themselves. Mr. Ricchi congratulated Bill and Joann Whitfield on celebrating their 60th wedding anniversary.

Council member Day announced the opening of the Uptown Art Gallery featuring local artists. Mr. Day stated that a new Italian ice cream store is opening on the Square.

Council member Kever complimented the Samaritan Inn on their good work. Ms. Kever invited everyone to the Parks, Recreation and Open Space public input meeting this Thursday for the upcoming City owned tennis facility. The McKinney Community Development Corporation is honing in on hiring an Executive Director and anticipates they will be bringing someone forward in the next four to six weeks.

Council member Brooks stated he is proud of the City of McKinney and the work a number of people are doing to make it a balanced city.

Council member Ussery thanked the staff for what they do every day and complimented the Fire and Police Department for what they do every day.

Mayor Pro-Tem Huff stated that he and the Mayor will be traveling to the Woodlands tomorrow for a Texas Aviation Conference. "Attendance at this conference will keep our foot in the door for Texas aviation funding." Mr. Huff saluted the Public Safety Department for the professionalism they exhibited to last week's tragedy.

City Manager Ragan thanked the Council for their acknowledgement of the Fire and Police Departments' efforts during last week's tragedy. "I am an extremely proud City Manager. It could not have been handled more professionally and the outcome could not have been better."
