Mayor Loughmiller called for Consideration/Discussion/Action on Filling the Vacant Position on the McKinney Arts Commission. Council unanimously approved the motion by Council member Kever, seconded by Council member Day, to table this item until the March 15, 2010 Work Session. 09-127SP

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by the City Of McKinney, for Approval of a Site Plan for a New Clubhouse at the Oak Hollow Golf Course, Approximately 142.36 Acres, Located on the West Side of State Highway 5 (McDonald Street) and Approximately 650 Feet South of Wilmeth Road TABLED FROM THE FEBRUARY 2, 2010 MEETING. Planning Director Jennifer Cox stated that the City is proposing to construct a new 4,300 square foot clubhouse at the Oak Hollow Golf Course on the site of the old clubhouse. Ms. Cox stated that the Planning and Zoning Commission approved this item at their January 12, 2010 meeting. Mayor Loughmiller called for public comments and there were none. Council unanimously approved the motion by Council member Ussery, seconded by Council member Kever to approve the site plan for a new clubhouse at the Oak Hollow Golf Course, approximately 142.36 acres, located on the west side of State Highway 5 (McDonald Street) and approximately 650 feet south of Wilmeth Road with the following conditions: The applicant satisfy the following conditions as shown on the Standard Conditions for Site Plan Approval Checklist: approval of building permit plans by the Chief Building Official, approval of architectural building elevations, in accordance with Section 146-139 of the Zoning Ordinance, by the Chief Building Official, approval of grading and drainage plans by the City Engineer, approval of public improvement construction plans by the City Engineer, approval of utility construction plans by the City Engineer, final location of fire hydrants be subject to review and approval by the Fire Marshal, the applicant provide any additional easements as determined necessary by the City Engineer, the applicant comply with the requirements of the Tree Preservation Ordinance and obtain any necessary tree permits within the time frames specified within the Ordinance, subject to review and approval by the City Arborist, and all signage is to comply with the current Sign Ordinance of the City of

McKinney, and as amended, final location of all signage, as well as the dimension and construction specifications, be subject to review and approval by the Chief Building Official, under separate permit.

Mayor Loughmiller called for City Council and Manager Comments.

Council member Brooks stated that the City Council had a very good joint meeting with the McKinney Economic Development Corporation where we discussed a lot of important issues. We discussed the McKinney Economic Development Alliance that was formed by all the bodies in the City who have an interest in economic development. We will be embarking on that in the next month. We remain focused on the economic development priority of the City.

Council member Ussery recognized Mr. Al Alford who touched a lot of lives and he was a very positive influence on the community. Mr. Ussery thanked staff for all that they do, day in and day out, for the City. Mr. Ussery recognized Mayor Loughmiller for the hours he puts in. "You have laid a good foundation, don't get tired."

Mayor Pro-Tem Huff stated that many of the Council members attended the Firemen's Award Banquet last weekend. There were some excellent recipients and it makes you very proud. Mr. Huff stated that he enjoyed the Community Band that performed at the McKinney Performing Arts Center. They are a wonderful example of how the arts have grown in McKinney.

Council member Ricchi stated that he served as Guest Conductor for the Community Band Concert. "There is a tremendous amount of talent in our community not only from the members of the band but from the people who put it together." Mr. Ricchi invited every McKinney resident to the Heard Museum on February 21st for free admission. Mr. Ricchi invited the public to attend the public input meetings regarding the McKinney Performing Arts Center on February 18th from 9 a.m. to 11 a.m. and on March 9th at 5:00 p.m. Mr. Ricchi invited residents who would like to apply to serve on the McKinney Arts Commission to turn in an application by March 10th for consideration. Mr. Ricchi stated that Mr. Al Alford was one of McKinney's true heroes and he will be missed and not forgotten. Mr. Ricchi reminded everyone to go out and vote in the Republican and Democratic parties primaries going on now.

Council member Day did not have any comments.

Council member Kever stated that she attended a brown bag lunch at Craig Ranch and had the opportunity to discuss City issues. Ms. Kever shared the Council's priorities and the upcoming bond proposals. Ms. Kever expressed her appreciation to Deputy City Manager Rick Chaffin and Executive Director of Development Services John Kessel for their willingness to meet with some of these folks to talk about their issues.

Mayor Loughmiller thanked the Boy Scouts in attendance at the meeting. Mr. Loughmiller expressed his appreciation to the citizens who come to the Council meeting and speak during citizen comments. "We pay attention to those comments." Mr. Loughmiller stated that the two McKinney Arts Commission public meetings and the Town Hall Meeting regarding MPAC reflect the Council's desire to listen to input from both sides on issues. Mr. Loughmiller stated that economic development is the number one priority for council. "The Council established priorities for the next 12 months." Mr. Loughmiller stated that he attended a meeting regarding access to McClure Elementary School. TxDOT has agreed to install a continuous right turn lane 300 feet back from the intersection. "I encourage everyone out there to educate themselves on what is on the upcoming bond election." Mr. Loughmiller stated that City Manager Ragan will be attending the County Commissioners meeting this week to request their support and financial participation in airport development.

City Manager Ragan stated that the 2010 Council priorities are now displayed in the Council Chambers. Mr. Ragan stated that these priorities have been incorporated in to the workplan and will be sent out to Council this week.

Mayor Loughmiller called for Citizen Comments.

Ms. Juanita Horne, 3191 Medical Center Drive, McKinney spoke about a parking garage for the downtown area.

Council unanimously approved the motion by Council member Ussery, seconded by Mayor Pro-Tem Huff, to adjourn. Mayor Loughmiller adjourned the meeting at 6:02 p.m.
