09-127SP Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on the Request by the City Of McKinney, for Approval of a Site Plan for a New Clubhouse at the Oak Hollow Golf Course, Approximately 142.36 Acres, Located on the West Side of State Highway 5 (McDonald Street) and Approximately 650 Feet South of Wilmeth Road. Planning Director Jennifer Cox stated that staff is requesting that this item be tabled for 2 weeks. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Kever, seconded by Council member Ussery, to continue the public hearing and table this item until the February 16, 2010 meeting.

Mayor Loughmiller called for a Public Hearing for Consideration of Propositions for the May 8, 2010 Bond Election. Assistant to the City Manager Aretha Harvey presented the bond propositions for public comment.

Council unanimously approved the motion by Mayor Pro-Tem Huff, seconded by Council member Ussery, to close the public hearing.

Mayor Loughmiller called for Council and Manager Comments.

Council member Ricchi stated that he and the City Attorney would be meeting with the residents of Heritage Bend to discuss their options. Mr. Ricchi stated that staff is working diligently on the traffic issues regarding McClure School and around Boyd High School. Mr. Ricchi stated that the City Council will be meeting with the McKinney Independent School District Board of Trustees next Monday. Mr. Ricchi expressed his support for the bond committee's actions and recommendations.

Council member Day expressed his disappointment that the bond committee recommended reducing the funding for the Historic Downtown parking garage from \$5M to \$3M.

Council member Kever expressed her appreciation for all the citizen support for the McKinney Performing Arts Center. "I haven't heard from Council that we are interested in shutting that facility down. We are open to suggestions for improving efficiencies. It is the heart for the arts in our community."

Council member Brooks expressed his appreciation to the bond committee for all their hard work. Mr. Brooks thanked all the citizens who attended the meeting tonight and provided their comments.

Council member Ussery recognized Contessa Corkern for her work with the McKinney Housing Authority (MHA) for Katrina and Rita disaster housing assistance.

Mr. Ussery thanked Arborist Emily Braht for her assistance with a problem in his district.

Mr. Ussery thanked staff for all that they do.

Mayor Pro-Tem Huff stated that the Fire Safety ISO rating went from a rating of 4 to a rating of 2. This should impact insurers in McKinney with a reduction in insurance costs for those who are insured with companies that use the ISO system.

Mayor Loughmiller thanked all the citizens who came to speak tonight regarding the McKinney Performing Arts Center. There will be two public hearings held over the next several months. Mr. Loughmiller invited the public to provide input and recommendations. Mr. Loughmiller expressed his appreciation for the work of the bond committee. We had a lot of different opinions and a balanced group representing all the interests of the community.

City Manager Ragan stated that the City has met with the Fire Department association about the issues of overtime. Mr. Ragan stated that we are ahead on our overtime spending and this is not a new situation. Mr. Ragan stated that the City will not brown out any station nor lock down any engine. Mr. Ragan stated that a series of tests are being administered to get fire fighters on the drivers list and captains list. This will enable us to step up people when people are out sick or on vacation and will help us manage our overtime and our personnel on any given day. "We cannot jeopardize our citizens' safety."

Mayor Loughmiller called for Citizen Comments and there were none.

Mayor Loughmiller recessed the meeting into executive session at 7:13 p.m. per Texas Government Code Section 551.071 (2) – Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed), Section 551.071 (1) (A) – Litigation / Anticipated Litigation, and 551.087 – Discuss Economic Development Matters as listed on the posted agenda. Mayor Loughmiller recessed to the open meeting at 7:44 p.m.

Council unanimously approved the motion by Council member Ussery, seconded by Council member Day, to adjourn. Mayor Loughmiller adjourned the meeting at 7:45 p.m.
