Council member Kever requested that this item be pulled down for discussion. Ms. Kever expressed her appreciation to the Bond Committee for the

time and effort they contributed to the successful bond election. Ms. Kever thanked the voters of McKinney for their support during these trying economic times. Council unanimously approved the motion by Council member Brooks, seconded by Council member Kever, to approved the Ordinance of the City Council of the City of McKinney, Texas, Certifying the Election Results for the May 8, 2010 Special Election. Mayor Loughmiller stated that all 6 bond propositions passed and these items will go on to the Capital Improvements Plan. Caption reads as follows:

- **10-214** Mayor Loughmiller called for Consideration/Discussion/Action on Filling the Vacant Position on the McKinney Housing Finance Corporation. Council member Brooks stated that the Council committee interviewed the candidates for this board last July and he would like to recommend appointing Alan Chapin to fill the unexpired term. Council unanimously approved the motion by Council member Brooks, seconded by Council member Ussery, to appoint Alan Chapin to fill the unexpired term, ending September 30, 2011, on the McKinney Housing Finance Corporation.
- **10-236** Consider/Discuss/Act on a Resolution in Support of Utilizing Accepted Wildlife Mitigation Practices by the North Texas Municipal Water District ("NTMWD") on the Heard Natural Wildlife Sanctuary ("Heard") Property to Preserve the Character of the Wildlife Sanctuary, the Species thereon, and the Environment in Conjunction with its Construction of a Sewer Line. Council member Ricchi requested that the Council approve the Resolution that urges the North Texas Municipal Water District to use their best efforts to put the Heard Natural Science Museum prairie lands and wetlands back in the condition that they found it. Mayor Loughmiller stated that the City's representatives on the North Texas Municipal Water

District Board supported mitigating these issues and that they previously suggested that they would do that. Mr. Loughmiller stated that the North Texas Municipal Water District had authority to pursue this route through condemnation without coming to the City Council and requesting some action on our part. This resolution that we have before us essentially is designed to show that we support and understand that we rely on the Water District to provide necessary services and that we also understand that we have a strong sense of what our Unique by Nature brand is and the fact that we value our natural wildlife environment. Council unanimously approved the motion by Ray Ricchi, seconded by Brian Loughmiller, to Approved Resolution in Support of Utilizing Accepted Wildlife Mitigation Practices by the North Texas Municipal Water District ("NTMWD") on the Heard Natural Wildlife Sanctuary ("Heard") Property to Preserve the Character of the Wildlife Sanctuary, the Species thereon, and the Environment in Conjunction with its Construction of a Sewer Line. Caption reads as follows:

Finance Director Jennifer Fung presented the application for the Raytheon Company to be designated as a Texas Enterprise project. Ms. Fung stated that Raytheon meets the criteria for tax relief and other incentives adopted by the City on the grounds that it will be located at the qualified business site, will create a higher level of employment, economic activity and stability. Ms. Fung stated that an Enterprise Zone is intended to encourage job creation and retention as well as capital investment in the community. Special incentives are available through the State of Texas for new and expanded business in the Enterprise Zone. The state can designate up to 105 enterprise projects every two years. To be an enterprise project, the business must create or maintain permanent full time jobs, make a capital investment at the site, hire at least 25 percent of new hires from enterprise zone residents or from economically disadvantage individuals and maintain this level of employment for its designated period. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Ricchi, seconded by Council member Kever, to close the public hearing and approve the Ordinance Nominating Raytheon Company to the Office of the Governor, Economic Development Bank as a Texas Enterprise Project. Caption reads as follows:

10-015Z Mayor Loughmiller called for а Public for Hearing Consideration/Discussion/Action on the Request by AutoZone Texas, L.P., on Behalf of ASG Eldorado Pavilion, Ltd., for Approval of a Request to Rezone Approximately 1.36 Acres from "PD" - Planned Development District to "PD" - Planned Development District, to Allow Neighborhood Business Uses, Located on the West Side of Ridge Road and Approximately 350 Feet South of Eldorado Parkway, and Accompanying Ordinance. Planning Director Jennifer Cox stated that the applicant is proposing to rezone approximately 1.36 acres of land, located on the west side of Ridge Road and approximately 350 feet south of Eldorado Parkway from "PD" - Planned Development District to "PD" - Planned Development District, to allow for neighborhood business uses. The subject property is currently zoned for office uses. The applicant has submitted an associated site plan which proposes an AutoZone on the subject property. Ms. Cox stated that when the nearby residential subdivision to the south was built, the zoning designating the subject property for office uses was already in place so the residents purchased their homes with the expectation that the subject property would be developed for office uses. Ms. Cox stated that staff is recommending Applicant, Mr. Bob Roeder, 1700 Redbud Trail, McKinney, denial. representing AutoZone, stated that the application passing the zoning test except for two criteria. It passes the test by conforming to the plans and goals test and does not cause any adverse impact on infrastructure or public facilities or city services, it does not constitute and over concentration of uses and exceeds the test in that it has a higher positive return to the City than an office building will be. It fails the test in that it is not shown on your Future Land Use Plan as retail. Mr. Roeder stated that they are requesting a neighborhood business use. Mr. Roeder stated that the current zoning would allow for a Child Care facility, indoor movie theater, bowling alleys, and large event centers that are allowed as a matter of right. Mr. Roeder stated that his client is willing to table this item for a few weeks to give them an opportunity to meet with the neighbors. Mayor Loughmiller called for public comments. The following individual did not wish to speak but requested that their opposition be entered into the record:

Mr. Joe Stewart, 3101 New York Avenue, McKinney Council member Brooks stated that he is opposed to this item. The residents, in a few days, were able to obtain over 70% of the residents signatures on a petition opposing this item. Council member Day is in support of this rezoning and for increasing the retail business in McKinney for the City and school district tax base. Mr. Day stated that a retail space will generate 5 times more taxes than an office building. Council member Brooks made a motion to deny the rezoning request. Mr. Brooks withdrew his motion. Mr. Brooks stated that he is very supportive of economic development but the answer is not to zone every piece of property in the community to retail development. Council unanimously approved the motion by Council member Kever, seconded by Council member Ussery, to close the public hearing and table this item until the June 1, 2010 meeting.

Mayor Loughmiller called for Council and Manager Comments:

Council member Ricchi invited everyone to the Oak Hollow Club House ribbon cutting on May 27th at noon with a golf tournament to follow. The Carey Cox Memorial Park dedication and grand opening will be held on May 26th. Mr. Ricchi stated that the construction of Ridge Road ahead of schedule and is predicted to be completed in time for the opening of McClure Elementary School. Mr. Ricchi wished Mayor Pro-Tem Huff a speeding recovery. Mr. Ricchi stated that the Leadership McKinney class held a Ping Pong Paluzza last week that has over 85 people participating and they raised over \$4,000 for McKinney Independent School District. Mr. Ricchi encouraged everyone to not only buy in McKinney but also to play and stay in McKinney. Mr. Ricchi announced that our newest La Quinta Hotel on 121 will be opening soon.

Council member Day wished Mayor Pro-Tem Huff a speedy recovery from his stay in the hospital. Mr. Day also wished City Manager Ragan a speedy recovery from

his stay in the hospital. Mr. Day invited everyone to attend the Art Walk in downtown McKinney this coming weekend.

Council member Kever echoed the well wishes to Mr. Huff and Mr. Ragan. Ms. Kever addressed the growing issue among the young people with K2 that is an herbal incense laced with Tetrahydrocannabinol which is the primary psychogenic in marijuana. It is legal to purchase it as incense, but when it is smoked, it has the same effect as marijuana. There are 13 countries and several states that have passed legislation to ban K2. Ms. Kever stated that she has contacted Senator Shapiro's office and she will be drafting a bill that will be sent to the City Council for our review.

Council member Brooks stated that he shares his colleague's concerns for Mr. Huff and Mr. Ragan and for their speedy recovery. Mr. Brooks stated that he supports Ms. Kever passion and efforts on the K2 issue.

Council member Ussery expressed best wishes to Mayor Pro-Tem Huff and City Manager Ragan. Mr. Ussery thanked staff for all that they do. Mr. Ussery thanked Council member Ricchi for allowing him to lead a Kids Council.

Mayor Loughmiller wished Mayor Pro-Tem Huff a speedy recovery so he can have the pleasure of rejoining the Council. Mayor Loughmiller wished City Manager Ragan a speedy recovery from his appendectomy. Mr. Loughmiller stated the Police Department, City Attorney's office and others have been working on the K2 issue. When this issue came to our attention, Staff immediately started investigating to see what could be done. "What came out of the investigation was that it needs to be addressed at the State level, and I support that legislation." Mr. Loughmiller announced that his 8th Grade Mock Trial team at Dowell Middle School won the Mock Trial competition this past weekend for Collin County Bar Association. Over 30 teams participated. This is the first time in the 15 year history of the competition that any McKinney school has won. "Congratulations to the 8th graders at Dowell Middle School for a great competition and look forward to next year."

Mayor Loughmiller called for Citizen Comments.

Ms. Juanita Horne, 3191 Medical Center Drive, #17106, McKinney, spoke about her concerns for the lack of development at US75 and Highway 121.

Mr. Terry Gaddis, 6316 Baltic Avenue, McKinney, stated that the Auto Zone request will create more traffic for the subdivision. Mr. Gaddis stated that there is no room on that site for a movie theater, bowling alley, or large entertainment venue.

Ms. Gilda Garza, 1208 Garcia Street, McKinney, spoke in support of the Heard Natural Science Museum and the McKinney Community Development Corporation Application for MaineGait. Ms. Garza requested that the City needs to be concerned about the residents around Old Settler's Recreation Facility when scheduling a Drum Festival for 11 hours. Next time put them out at Erwin Park or another Park west of US 75.

Mr. Nadine Winterroud, 3309 St. James Place, McKinney, spoke about maintaining the home values for the residents.

Council unanimously approved the motion by Council member Ussery, seconded by Council member Ricchi, to adjourn. Mayor Loughmiller adjourned the meeting at 7:25 p.m.
