Mayor Loughmiller called for Consideration/Discussion/Action on a

City Attorney Mark Houser stated that staff is recommending awarding the bid to the second lowest bidder due to the lowest bidder being a non-responsive bid. Mr. Daniels stated that they were the apparent low bidder on this project at \$478,204.05 and represents a fair price for the job. Council unanimously approved the motion by Council member Kever, seconded by Council member Brooks, to approve the Ordinance amending Chapter 70, Article VII, "Smoking," of the Code of Ordinances. Council unanimously approved the motion by Council member Brooks, seconded by Mayor Pro-Tem Huff, to overturn the Historic Preservation Advisory Board's decision and allow the installation of wood replacement windows at 402 Parker Street.

Council unanimously approved the motion by Council member Kever, seconded by Council member Ussery, to amend the previous motion to close the

public hearing and approve the Ordinance as presented.

- 10-048SP Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on the Request by the City of McKinney, for Approval of a Site Plan for the Veterans Memorial Park in McKinney, Approximately 0.57 Acres, Located on the Northeast Corner of Weiskopf Avenue and Collin David South Drive. Planning Director Jennifer Cox stated that the City is proposing to construct the Veterans Memorial Park at the northeast corner of Weiskopf Avenue and Collin David South Drive. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Brooks, seconded by Mayor Pro-Tem Huff, to approve the Site Plan for the Veterans Memorial Park in McKinney, located on the Northeast Corner of Weiskopf Avenue and Collin David South Drive with the following condition: the applicant satisfy the following conditions as shown on the Standard Conditions for Site Plan Approval Checklist: approval of building permit plans by the Chief Building Official; approval of architectural building elevations, in accordance with Section 146-139 of the Zoning Ordinance, by the Chief Building Official; approval of grading and drainage plans by the City Engineer; approval of public improvement construction plans by the City Engineer; approval of utility construction plans by the City Engineer; final location of fire hydrants be subject to review and approval by the Fire Marshal; the applicant provide any additional easements as determined necessary by the City Engineer; and the applicant comply with the requirements of the Tree Preservation Ordinance and obtain any necessary tree permits within the time frames specified within the Ordinance, subject to review and approval by the City Arborist..
- **10-044AA** Mayor Loughmiller called for a Public Hearing for Consideration/Discussion/Action on the Request by Cross Engineering Consultants, Inc., on Behalf of LINFER, L.L.C., for Approval of a Right-of-

Way Vacation (Bevoe Street), Approximately 0.08 Acres, Located Between State Highway 5 (McDonald Street) and Wilcox Street, and Accompanying Ordinance. Planning Director Jennifer Cox stated this is a request to abandon a portion of a right of way that is currently a section of Bevoe Street. Ms. Cox stated Staff has received a petition signed by both adjacent property owners agreeing to this request. Applicant, Mr. Dwayne Zin, 106 W. Louisiana, McKinney was available for questions and there was none. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Day, seconded by Council member Kever, to approve the Ordinance granting a right-of-way vacation (Bevoe Street), approximately 0.08 acres, located between State Highway 5 (McDonald Street) and Wilcox Street. Caption reads as follows:

10-061Z Loughmiller called for Mayor а Public Hearing for Consideration/Discussion/Action on the Request by John Thomas Engineering, on Behalf of Frank Williams, Jr., for Approval of a Request to Rezone Approximately 1.50 Acres, from "PD" - Planned Development District to "BG" - General Business District, Located on the Northwest Corner of U.S. Highway 380 (University Drive) and Graves Street, and Accompanying Ordinance. Senior Planning Michael Quint stated that the applicant is proposing to rezone approximately 1.5 acres from PD -Planned Development to BG – General Business. Staff is recommending approval with the conditions listed in the staff report. Applicant - John Measels, 7813 Great Divide Lane, McKinney, stated that they are requesting to rezone this property back to the previous BG zoning to remove an existing site plan. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the

motion by Council member Ussery, seconded by Council member Day, to approve the Ordinance rezoning approximately 1.50 Acres, from "PD" -Planned Development District to "BG" - General Business District, located on the northwest Corner of U.S. Highway 380 (University Drive) and Graves Street, with the following special ordinance provision: the subject property be developed according to "BG" - General Business District regulations. Mayor Loughmiller called for Council and Manager Comments

Council member Ricchi congratulated the Parks Department for the successful Hawaiian Night event. Mr. Ricchi announced that the Heard Natural Science Museum is offering McKinney residents free admission on July 25<sup>th</sup>, a Night Hike on July 24<sup>th</sup>, and Ice Age Mammals are there through October 10<sup>th</sup>. Mr. Ricchi congratulated the McKinney Convention and Visitors Bureau and Tourism Director Diann Bayes for their efforts with the filming of the television series The Chase in McKinney. Mr. Ricchi recognized Ms. Bayes for being selected to serve on the State board.

Council member Day stated that McKinney was named by Money Magazine as the fifth most desirable place to live in the Country. They based this recommendation on a large part to "A Gem of a Downtown." Mr. Day expressed his thanks to everyone that has worked for over a decade to create that downtown. "The City Fathers saw the need to change the ordinances that effected downtown to allow mixed uses." Mr. Day gave a special thanks to Chief Building Official Bennie Reed for not taking the hard line and making all buildings meet modern codes because they never would have been able to renovate the old buildings. Mr. Reed came up with renovation practices that made the buildings safer and let us put them back into use. Mr. Day congratulated the City for spending \$2 million in 2008 to renovate downtown, widened the sidewalks to allow the outside patio dining, widen the streets, repaired the landscaping, and made it a very desirable place.

Council member Kever stated that the Library Advisory Board has some outstanding members. Ms. Kever commended Library Board member Kathryn Wait for suggesting, after hearing there are \$500,000 in past due fines, an innovative way to collect the past due fines. Ms. Kever mentioned that she attended a TML Legislative update in Arlington. Ms. Kever mentioned that properties are desirable along our southern border due to Highway 121 and the easy access to the DFW airport. There is a real link between economic development and our roads. Ms. Kever mentioned that the North Texas Tollway Authority is vetting through the alignment for the north extension of the Dallas North Toll Road.

Council member Brooks stated that the Armed Services Memorial Board has surpassed their goal to complete the Veterans Memorial. Mr. Brooks stated that the McKinney Economic Development Corporation is working through some incentives to attract jobs and economic development in McKinney.

Council member Ussery stated that the Planning & Zoning Commission met on July 13<sup>th</sup> and acted on the rezoning case we heard tonight along Highway 380. Mr. Ussery thanked Staff for their efforts every day and the number 5 ranking does not come from Council but from what you do day in and day out. "We have made some mistakes but McKinney has done a lot of things right and the staff and citizens are a big part of it."

Mayor Pro-Tem Huff stated that the McKinney Community Development Corporation (MCDC) met on June 24<sup>th</sup>. They adjusted this year's sales tax expectation down. MCDC addressed the expiration of the agreement with the Paul Kike Company who had planned on building a data center in McKinney but had not met their time commitment. MCDC is working on their strategic plan, grant processes and time line, and criteria. Mr. Huff stated that this year the October Fest will be held for 2 days along with making Dickens bigger & better. Mr. Huff stated that he attended a special meeting at Commissioner's Court where they discussed redistricting at the state level. County

Commissioner Joe Jaynes is working on trying to keep from splitting any city into multiple districts or at least no more than two per city.

Mayor Loughmiller stated that Council member Day, Interim City Manager Rick Chaffin, our consultant and he attended a meeting with Judge Keith Self. Mr. Loughmiller stated that he has joined with other Mayors and City Managers in Collin County to unify on issues that we would like the Commissioners Court to address. "We will be going in front of the Commissioners Court on August 16<sup>th</sup> to discuss TIF districts for the Airport and Highway 5 corridor and request County participation. City of McKinney has been fortunate in the last 6 months to get a lot of recognition through different publication with the latest being the Money Magazine's the 5<sup>th</sup> Best City to Live, Live Healthy North Texas Award, tonight's Finance Reporting award, and the award we received from the State Comptroller for transparency in reporting, and last year McKinney was recognized as One of the Safest Cities in America. A lot of these awards are coming about due to the sense of community we have here in McKinney. Mr. Loughmiller congratulated the citizens of McKinney. Mr. Loughmiller stated that Main Street has put together a brochure that lists the restaurants and shops in downtown. Mr. Loughmiller suggested that we make an effort to these brochures out in other areas of the City to build a larger awareness of what is going on in downtown.

Interim City Manager Chaffin stated that the McKinney Economic Development Alliance members which is a partnership between the City, the Chambers of Commerce, McKinney Economic Development Corporation, and McKinney Community Development Corporation. Through this group, they are working with TIP Strategies to look at a number of our corridors and how best to develop these corridors. Serving on the Committee for the City are the Mayor, Council members Day & Brooks, John Kessel, and Aretha Harvey. This is a high priority and we are working on this almost daily.

Mayor Loughmiller called for Citizen Comments and there were none.

Mayor Loughmiller recessed the meeting into executive session at 8:07 p.m. per Texas Government Code Section 551.071 (2) Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as CITY COUNCIL MINUTES JULY 20, 2010 PAGE 18
