Planning Director Jennifer Cox stated that the applicant is requesting to rezone the subject property from single family and office uses to single family subdivision development. She stated that the applicant is requesting to remove the office designation which would still leave a retail corner at the intersection of Alma Road and Silverado Road but would do away with the 17 acre tract of office currently located in the subject She stated that Staff recommends denial of the proposed rezoning request. Ms. Cox stated that density dropped from 4.7 units per acres to 4.2 units per acre which does not include the multi-family component. Applicant, Mr. Bob Roeder, 1700 Redbud, Suite 300, McKinney, stated that there is a reduction in density and that they are

proposing that the front exterior of the homes be 100% masonry and the total exterior be 75% masonry. He stated that McKinney's Future Land Use shows the subject area to be for residential use not commercial use. Mayor Loughmiller asked if the zoning for the Frisco ISD site could be used for multi-family in case the school does not get built. Mr. Roeder stated that he has not spoken to the school district about it yet the school district will begin breaking ground very soon with a projected school opening in the fall of 2012. . Mayor Loughmiller stated he is in favor of reducing the density and there was a similar case back in the mid 90's where Prosper ISD was going to build a school and then decided not to build the school. It remained a 10 acre site until the issue was settled by building a neighborhood park. City Manager Gray stated that the City could talk with Frisco ISD about a City initiated rezoning. He stated that he did not think that Frisco ISD would object to the rezoning since they have every intention of building the school. Mr. Roeder stated that his client is willing to agree that he will have a connectivity in place when the school opens regardless of where the development starts within the subject property. Ms. Cox stated that the there is no adjoining park to the school because the road network to help get the traffic through the subdivision and back onto the arterial roadways would run between the open space play area and the school. Ms. Haley is in favor of the proposed development. Mr. Gray explained that he understood why Staff is recommending denial due to City Council's direction in trying to maintain commercial corridors. He stated that there is a difference between a strong recommendation for denial and denial that is based on previous comments and statements of the Council. Mayor Loughmiller called for public comment. The following individuals spoke in favor of the rezoning request:

Mayor Loughmiller called for Council and Manager Comments and Liaison Reports

Council member Ussery commended Staff for what they do day in and day out.

Mr. Ussery welcomed City Manager Jason Gray as a good addition to the City.

Mayor Pro-Tem Huff stated that he attended a Community Development Corporation Board meeting on March 24th that included a number of action items. Parks, Recreation, and Open Space Director Lemuel Randolph presented nine options for an Aquatic Center that will be funded in part by the McKinney Community Development Corporation. Mr. Huff congratulated the Planning staff for taking to heart the Council's vision for land development.

Council member Ricchi stated that the McKinney Convention and Visitors Bureau will be launching in May a new application for the IPhone and Blackberry that will provide information on the events going on in McKinney. The Blooming & Booming campaign will begin on June 10th and end with the Red, White, and Boom celebration on July 4th. Mr. Ricchi announced that the Heard Natural Science Museum has an exhibit showing two dinosaurs in mid-conflict, 25 different bugs on display, and a wet lands canoe trail voyage on April 2nd. April 30th is a free day at the museum for McKinney residents.

Council member Day invited everyone to downtown McKinney this Saturday for an Art Walk with 150 artists, food vendors, music, choir, and a good time for everyone.

Council member Kever stated that the McKinney Arts Commission met on March 24th where they are pressing through a Public Arts program that will be brought before the Council in the near future. Ms. Kever attended a Chamber meeting where there was a presentation of the census data that will show where McKinney is growing. Ms. Kever stated that dirt will be flying over the next 40 months on a roadway project along US 75 from 121 to Melissa.

Loughmiller extended his congratulations and regrets that he will be unable to attend

the celebration. Mr. Loughmiller stated that the Communications and Marketing staff is

during the "Get Fit in May" campaign.

City Manager Gray stated that he is happy to be here and thanked the Council
