JANUARY 3, 2012

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on January 3, 2012 at 6:00 p.m.

- 12-018 Mayor Loughmiller called for Consideration/Discussion/Action on Designating Term Length for New Appointees to the McKinney Armed Services Memorial Board. City Secretary Sandy Hart stated that Mark Stoddard and James Morrell were appointed on December 6th to the McKinney Armed Services Memorial Board to fill two unexpired terms. Ms. Hart stated that Council will need to designate which appointee would fill the 2 year unexpired term and which one would fill the one year unexpired term. Council unanimously approved the motion by Council member Brooks, seconded by Council member Ricchi, to designate Mark Stoddard to fill the term ending on September 30, 2013 and James Morrell to fill the term ending on September 30, 2012.
- 12-019 Mayor Loughmiller called for Consideration/Discussion/Action on Filling the Vacant Position on the McKinney Housing Finance Corporation. City Secretary Sandy Hart stated that there is one opening to fill the unexpired term ending on September 30, 2012 on the McKinney Housing Finance Corporation Board. Council unanimously approved the motion by Council member Brooks, seconded by Council member Kever, to appoint Brian Dale to fill the unexpired term ending September 30, 2012 on the McKinney Housing Finance Corporation.
- **11-577** Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution to Authorizing a Design/Build Contract for the Baseball Fields at Gabe Nesbitt Park. Parks, Recreation, and Open Space Director Lemuel Randolph stated that the proposed resolution is to award a design/build contract for the baseball fields along with the skate park to

determine if economies of scale could be achieved with the prospect of developing these projects together. Mr. Randolph stated that the award of this design/build contract will allow the consultant and staff to evaluate the cost associated with building the baseball fields and locating the skateboard park to a more central location. He stated the cost to build the skateboard park would increase if it were to be built on its own due to additional drainage required on the a separate site. He stated that in order for the consultants to analyze the proposal they need to move forward with the contract. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Kever, to approve the Resolution authorizing a Design/Build Contract for the Baseball Fields at Gabe Nesbitt Park.
