JANUARY 17, 2012

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on January 17, 2012 at 6:00 p.m.

Council unanimously approved the motion by Council member Harris, seconded by Council member Kever, to appoint Travis Ussery as Chairman of the Reinvestment Zone Number Two
- 12-051 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing the Execution of Documents for the Acquisition of Right-of-Way/Easements and the Consideration of the Use of Eminent Domain to Condemn Property for the West Street Infrastructure Initiative Project along West Street from Bonner Street to Erwin Avenue. Director of Engineering Jack Carr explained the execution of documents for acquisition of easements and right-of-way along West Street from Bonner Street to Erwin Avenue and stated that due to Senate Bill 18 that came into effect starting September 2011 now requires a recorded vote. Mr. Carr stated that staff tries to contact the property owners first to reach a fair market value and then purchase at an agreed value with condemnation used as a last resort.

Mr. Carr stated that some of the property that is being asked for is about 27 to 900 square feet. City Manager Gray stated that they will not move to condemnation unless it is absolutely necessary. Council unanimously approved the motion by Council member Kever, seconded by Mayor Pro-Tem, to approve the Resolution and authorizing the use of the power of eminent domain to acquire all necessary right-of-way and easements from the property owners, labeled 1 through 5, indicated on the attached property locator map for

the West Street Infrastructure Initiative Project. City Secretary Sandy

Mayor Pro-Tem Ussery stepped down for the following item.

12-052 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Approving Funding Recommendations under the FY 2012 Community Support Grant. Grants Administrator Janay Tieken presented the recommendations for the FY2012 Community Support Grant funding. Ms. Tieken stated that \$592,548 was requested and \$119,700 was approved by City Council to support non-profit agencies serving residents of McKinney. Ms. Tieken stated that City Council established the Community Support Grant program to establish a process for evaluating requests from non-profit agencies that provide

activities, programs, and services to residents of McKinney. Organizations, which can be reasonably categorized under the heading of providing a public service and that promotes the health, safety and welfare of McKinney residents, are eligible for funding. Council unanimously approved the motion by Council member Kever, seconded by Council member Harris, to approve the Resolution approving funding recommendations under the FY 2012 Community Support Grant. Council member Ricchi recognized Randy Moss that was in the audience, Mr. Ricchi Mr. Joplin and Mr. McKissick for the work that they do during this challenging water situation.

Council member Day did not have any comments.

Council member Kever extended a big thank you to Rob Daake, Jack Carr, Gary Graham, City Manager, and Mayor for the time that they are going to spend this week on transportation related issues. Dallas District Engineer, Bill Hale will be in McKinney on Friday and they will be giving him a tour of the City of McKinney to show him the roadway projects that are going on in McKinney. She stated that Council approved the Engineering Phase FY2012 Transportation Improvement program budget for the engineering Phase from F.M. 546 west of County Road 317 to U.S. Highway 5. Ms. Kever applauded Staff for their work as they begin the preliminary discussions related to our budget. She invited the public to come look at the art that is being displayed at City Hall as well as the Development Services building. Ms. Kever thanked the Police Department for responding quickly to her house alarm that went off from a golf ball breaking a window.

Council member Harris thanked Staff for all they do and complimented the City Manager on the retreat that was held last Friday. The content was very interesting and well put together. Mr. Harris expressed his appreciation for working with the City Manager's staff and their willingness to bend over backwards and help the citizens of McKinney. Mr. Harris announced that Jim Young will be stepping down at the end of the month from the McKinney Economic Development Corporation. Mr. Harris thanked Joe Joplin and Charles McKissick for representing the City of McKinney on the North Texas Municipal Water District Board.

Mayor Pro-Tem Ussery thanked Staff for what they do day in and day out and stated that he just doesn't say it to say it, but he really means it. As a citizen he applauded the Mayor's efforts in the economic development area.

Mayor Loughmiller stated that the Planning Retreats are open to the public if anyone is interested. We talk about budget but also talk about long range planning and projects we would like to see move forward. Mr. Loughmiller stated that last year they established May as Get Fit Month. City staff along with any residents can participate in Live Healthy North Texas. Any resident that would like to participate can pay a nominal fee of \$20 When logging into the website, use code LHT so we can monitor people who live in McKinney and their efforts through this organization.

City Manager Gray stated that the Live Healthy Texas details will be on the City's website tomorrow.
