Director of Planning Michael Quint stated that the applicant is requesting to rezone the property to reorient the configuration of existing lots to east/west instead of north/south. In order to do that they would need special ordinance provisions pertaining to the lot width specifically reducing from 50 to 46. He stated that this item was tabled at the December meeting so that Habitat for Humanity could reach out to the adjacent residents. Mr. Quint stated that staff recommends approval of the proposed rezoning request. Mr. Quint stated that staff considered the request that was submitted with 3 lots and had no objections. If Council would like to have 2 lots instead of 3, then staff would be supportive of Ms. Celeste Cox, Director of Collin County Habitat for that as well. Humanity stated that they have built 16 homes adjacent to that property and almost every home they have built in that area are on lots less than 50 feet in width and they have had to obtain variances. She stated that at the last meeting there was a fence issue that has since been resolved. Mayor Loughmiller called for public comment.

Ms. Gilda Garza 1208 Garcia Street, McKinney spoke against the rezoning request. Council unanimously approved the motion by Council member Day, seconded by Council member Kever, to close the public hearing and approve an Ordinance rezoning approximately 0.46 acres from "RS 60" - Single Family Residence District to "PD" - Planned Development District, generally to modify the development standards, located on the northwest corner of Lively Hill and Monterey Street with the following special ordinance provisions: use and development of the subject property shall conform to the regulations of "RS 60" - Single Family Residence District, and as amended, except as follows:

Director of Planning Michael Quint stated that the applicant is requesting to replat the subject property from 1 lot to 2 lots. He stated that whenever someone subdivides property each property must provide direct access to public infrastructure. The lot was platted as one lot and not as two, there is a private water line that comes from Mercury Circle back to serve the western part of the building and to split the property down the middle would deny the western part of the building direct access to the public utility and Mercury Circle. Mr. Quint stated that there is a 2 inch line that is currently serving the building and the city engineer feels as though that is sufficient and they are supportive of the variance to not extend public infrastructure to that lot. He stated that staff recommends approval. Application, Mr. John David Cross, 131 S. Tennessee Street, McKinney, stated that they have read staffs comments and are in agreement. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Brooks, seconded by Council member Day, to close the public hearing and approve a Preliminary-Final Replat for Lots 4R1 and 4R2, Block A, of the Power House Business Park Addition, being less than 1 acre, located approximately 200 feet south of Power House Street and on the west side of Mercury Circle.

He stated that state law requires that prior to annexing a piece of property that it go through three public hearings. The first public hearing was held tonight at the Special Meeting. This is the second public hearing and the final public hearing will be held on February 5, On February 5, 2013, the Council will also consider a 2013. development agreement as well as the associated rezoning request. Staff recommends that Council hold the second public hearing and take no further action taken tonight. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Kever, seconded by Mayor Pro-Tem Ussery, to close the public hearing.

Mayor Loughmiller called for Council and Manager Comments

Council member Ricchi welcome everyone back from the holidays. Mr. Ricchi stated that he had the great pleasure of serving under Bill Dowdy on the MEDC Board. He was a very good man and cared about the City of McKinney and his legacy will continue for a long time. Mr. Ricchi complimented the public safety staff for the responses they provided over the holidays that provided a reassurance that we are all safe in this community. The fire department provided a fire rescue at Storybook Ranch where everyone concerned was safe and walked away. This is accredited to Chief Kistner and the training and preparation of the McKinney Fire Department. Mr. Ricchi stated that was a police instance recently that was diffused and there were no injuries

Ms. Kever stated that she has a meeting this Thursday with TX21 that is looking hard at the future of US 75. Ms. Kever stated that she is also looking forward to the Strategic Planning Retreat our January 31st.

Council member Harris suggested that the City consider naming something in honor of Bill Dowdy, Jr. to continue his legacy in the City of McKinney. Mr. Harris thanked the staff in public safety for handling the situation on Custer Road and the apprehension of the armed robbery suspect. Mr. Harris expressed his appreciation to Staff for working with the Town of Prosper on determining why the speed limit needs to be reduced along Custer Road north of US 380.

Council member Brooks announced that he will not be seeking reelection in May. Over the next 4 months he is looking forward to bringing some projects to conclusion including the Gateway Project. He expressed his appreciation for being part of the great leadership here in McKinney and he is looking forward to good things ahead.

Mayor Pro-Tem Ussery tipped his hat to Council member Brooks for his energy and service on the Council. Mr. Ussery thanked staff for what you do day in and day out and you do everything the best as you come to work each and every day. Mr. Ussery wished Council member Ricchi a happy birthday.

Mayor Loughmiller expressed his appreciation to Council member Kever for her comments about attending a retreat on her birthday since he celebrated his 25th anniversary at the State of the Community. Mr. Loughmiller stated that as we move into

our Strategic Planning retreat the goal will be to identify our priorities for the next year or year and a half and to make sure we are moving forward strategically towards the completion of those goals. The City will be kicking off our health initiative in conjunction with the School District, Baylor Hospital, McKinney Medical Center. The kickoff will begin on January 28th through April 3rd with the Live Healthy Texas program. We are going to try to have a coordinated effort year round with events throughout the calendar year focused on promoting a healthy lifestyle and healthy community in McKinney. There has been a lot of discussion lately on US 75 corridor as it relates to Interstate status versus no interstate status. No decisions have been made and it has been more questions than answers. We are a long way off from understanding all the pros and cons of that issue. Mayor requested that a work session be identified once a month to hear updates.

City Manager Gray stated that we have a new Citizens Police Academy starting up on January 31st and encouraged citizens who are wanting a better understanding of the McKinney Police Department to sign up on the City's website. The City's 2012 Annual Report has been published on the City's website and Mr. Gray encouraged interested citizens to take a look at the report.

Mayor Loughmiller called for Citizen Comments and there were none.

Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Harris, to adjourn. Mayor Loughmiller adjourned the meeting at 6:55 p.m.
