#### CITY COUNCIL REGULAR MEETING

#### MARCH 19, 2013

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on March 19, 2013 at 6:00 p.m.

Council member Kever stated that she and the Mayor had conducted the interviews for this back in the fall and reminded council that this is a 5 member board with 2 members appointed as alternates. She stated that the recommendation from the Mayor and her is to appoint Alternate Charles Shepard to fill the unexpired term and leave the open Alternate position open until the annual appointments in August. Council unanimously approved the motion by Council member Harris, seconded by Council member Day, to appoint Charles Shepard to fill the unexpired term on the Board of Adjustment ending September 30,

2013.

Director of Planning Michael Quint stated that the applicant is requesting to annex approximately 3 acre property into the City of McKinney. Mr. Quint stated that Staff evaluated factors such as current population, ability to provide city services, and fiscal impact to the city and has no objections. Mr. Quint stated that this is the second of three public hearings. The first one was held last night at 5:30 p.m., this is the second public hearing, and the third public hearing will be held on April 16, 2013 at 6:00 p.m. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Kever, seconded by Council member Harris, to close the public hearing.

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by Sanchez and Associates, on Behalf of Today McKinney Ranch II, L.P., and TCI McKinney Ranch, Inc., for Approval of a Request to Rezone Fewer than 34 Acres from "AG" - Agricultural District, "PD" -Planned Development District, and "REC" - Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" -Regional Employment Center Overlay District, to Allow for Single Family Residential and Commercial Uses, Located on the Northeast Corner of Stacy Road and Future Collin McKinney Parkway, and Accompanying Ordinance. He stated that the proposed lots are consistent with size and shape that is currently found within the Village Park development and some of the special ordinance provisions that are being sought are consistent with that development. Applicant, Mr. Levi Wild, 220 East Virginia Street, McKinney, stated that they are in agreement with staff's comments. Mayor Loughmiller called for public comment and there was none. 13-275 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing the City Manager to Execute a Six-month Emergency Services Agreement with Robinson Aviation, Inc. to Provide Air Traffic Control Services (ATCS) at Collin County Regional Airport (TKI). Airport Executive Director Ken Wiegand stated that on March 5, 2013, the FAA notified the City that the control tower was on the list that would not be funded beyond April 7, 2013. He stated that there are 19 airports in Texas that are affected by this and almost 48 percent of all the towers in Texas that will be closed are non-funded. He stated that since the notification they worked on 2 efforts to retain the airport funding and one of them is through congressional efforts and were notified that both efforts have failed. Mr. Wiegand stated that the second effort was submitting a letter that asks that the tower be removed from the list for reasons that closing the tower would have a negative impact on national interest and are scheduled to receive feedback on Friday March 22, 2013. He stated that he took this issue to the Airport Board on March 14, 2013 and discussed 5 options on how they might make a

recommendation to Council. The Board recommended that the tower

remain open for safety and economic development. City Manager Gray

stated that if things did not change, he would bring forward a line item in the proposed FY 2014 budget that would address this issue. Council member Harris stated that this is a huge issue and McKinney has gone a long way to bring in corporations and development because of the airport. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Harris, to approve the Resolution presented tonight authorizing the City Manager to execute a six-month Emergency Services Agreement with Robinson Aviation, Inc. to provide Air Traffic Control Services (ATCS) at Collin County Regional Airport (TKI). Caption reads as follows:

Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Supporting the Designation of an Interstate Highway Route Beginning at the Junction of Interstate Highway 30 and the Outer Loop in Rockwall County, Continuing North and West Along the Future Alignment of the Outer Loop to its Junction with US 75 and then Continuing North Along US 75. Transportation Engineering Manager Gary Graham stated that this Resolution takes the following actions: supports the designation of an interstate highway route beginning at the junction of Interstate Highway 30 and the Outer Loop in Rockwall County, continuing north and west along the future alignment of the Outer Loop to its junction with US 75 and then continuing north along US 75; supports the efforts of Collin County officials to have the Outer Loop added to the 2040 Mobility Plan; and supports the concept that the Outer Loop should serve as a bypass of the Metroplex, thereby allowing the section of US 75 from McKinney to Dallas to be used as a commuter corridor, as it functions today. Mr. Graham stated that it is staff's recommendation to bring the interstate down to US 75 and take it across the outer loop down to Interstate 30. Mr. Graham stated that an Interstate can be terminus in different locations and this proposed alignment would terminate at I30 and I44 in Oklahoma. Mayor Loughmiller stated that he would not support interstate status through the City of McKinney from what he has heard and seen in the community. City Manager Gray stated that there are some economic development prospects that use proximity to an Interstate as their criteria. Council unanimously approved the motion by Council member Kever, seconded by Mayor Pro-Tem Ussery, to approve a Resolution supporting the designation of an Interstate Highway Route beginning at the junction of Interstate Highway 30 and the Outer Loop in Rockwall County, continuing north and west along the future alignment of the Outer Loop to its junction with US 75 and then continuing north along US 75. Caption reads as follows:
