12-823 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Approving the Recommendations of the Arts Commission for Awarding Grants for Funding of the Arts. Mayor Loughmiller questioned

the addition of \$12,000 for Public Art Funding. Assistant to the City Manager Aretha Adams stated that the Arts Commissioners came to a consensus that they wanted to propose to the Council to fund \$12,000 toward a public art trust fund and would still attempt to acquire private funding to match the \$12,000. Chairman Spina stated that the allocations that the Commissioners have submitted are for this year that includes the \$12,000 for the public art trust fund without any assumptions that this would be done in future year allocations. Mayor Loughmiller stated that he takes issue with the fact that the document that was approved by Council clearly stated that the policy was going to be funded through private contributions. If we are now changing that policy going forward than the Council needs to look at the document again and revisit it. If it is the policy of the Council to allow a certain percentage of the arts funding allocated for the public art trust fund on a matching fund basis, then that needs to be written into the policy so that anyone who is applying for funding understands it. Council unanimously approved the motion by Council member Harris, seconded by Council member Day, to approve the Resolution recommending the Arts Commission Awarding Grants for Funding of the Arts with the \$12,000 allocated to the Public Art Trust Fund be conditioned upon a dollar for dollar match from the private sector before the City's matching money is expended and with no other funds from public sources. Council member Kever thanked all the volunteers and the public response during the rainy Oktoberfest last weekend. Ms. Kever announced that there is a neighborhood revitalization which is part of a city-wide outreach initiative "Cities of Service" that will be going on Saturday, October 6th. Habitat for Humanity, citizens of McKinney and those associated with 3E are coming together for a neighborhood cleanup response. Ms. Kever encouraged everyone to get involved by contacting Habitat for Humanity and help the efforts on October 6, 13th, 20th, and 27th.

Mayor Pro-Tem Ussery stated that a lot of hard work went into Oktoberfest and it was much appreciated. Mr. Ussery thanked staff for what they do.

Council member Brooks did not have any comments.

Council member Harris did not have any comments.

Mayor Loughmiller mentioned that there will be over 500 volunteers at the 1st weekend of Cities of Service. He stated that we can certainly use more volunteers for all 4 weekends. There have been 82 properties that have been identified in this first neighborhood cleanup project. Mr. Loughmiller stated that the accolades that the City has been receiving is attributable to the volunteers, the community, and the private sector who are willing to set up and help the community. Mr. Loughmiller mentioned that last Saturday was a memory walk for Alzheimer that was well attended despite the wet weather. This coming Saturday is Wish 100 bike ride starting in downtown McKinney benefiting the Make a Wish Foundation.
