#### CITY COUNCIL REGULAR MEETING

### MARCH 18, 2014

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on March 18, 2014 at 6:00 p.m.

Council unanimously approved the motion by Council member Kever, seconded by Council member Pogue, to approve the Minutes of the City Council Special Meeting of February 28, 2014.

Mayor Pro Tem Ussery called for the Minutes of the City Council Regular Meeting of March 4, 2014. Council member Pogue asked that the minutes be corrected referencing Gary Graham's name. Council unanimously approved the motion by Council member Harris, seconded by Council member Pogue, to approve the Minutes of the City Council Regular Meeting of March 4, 2014 with the correct spelling of Gary Graham's name.

Council member Pogue stepped down from the dais on the following agenda item.

14-011Z3 Hearing Mayor Pro Tem Ussery called for а Public Consider/Discuss/Act on the Request by McKinney Christian Academy, for Approval of a Request to Rezone Fewer than 60 Acres from "PD" -Planned Development District to "PD" - Planned Development District, Generally to Modify the Development Standards, Located on the South Side of Bois D'Arc Road and Approximately 800 Feet West of Jordan Road, and Accompanying Ordinance. Planning Director Michael Quint stated that the applicant is requesting to rezone the subject property, to allow the addition of two portable buildings to be permitted on the subject property for an indefinite period of time while not meeting the architectural standards. City Staff went out to the site to observe traffic patterns or circulation and there were no significant increases in queuing or stacking in the right-of-way. City Staff is not recommending any changes to the current circulation pattern on the site but will continue to Mr. Quint stated that adding a sunset clause to the monitor the area. approval with a limit of how long the buildings can remain may be become difficult from an enforcement stand point. Applicant, Mr. Bob Lovelady, McKinney Christian Academy, 3601 Bois D'Arc Rd., McKinney, TX, stated that McKinney Christian Academy (MCA) stated as they build and continue to make big investments in the school, these two modular buildings will help as they get to the next phase of building out the strategic plan of the entire campus. These buildings provide MCA the ability to continue to grow and raise funds to build the new buildings. Mayor Pro Tem Ussery called for public comment. Council approved the motion by Council member Kever, seconded by Council member Harris, to close the public hearing, with a vote of 5-0-1, Council member Pogue abstaining. Council member Ricchi requested that the City look into putting a school zone in the area to help alleviate some of the problems. Council member Day suggested reducing the Council approved the motion by Council speed limit in the area. member Kever, seconded by Council member Harris, to approve an Ordinance rezoning fewer than 60 Acres from "PD" - Planned Development District to "PD" - Planned Development District, generally to modify the Development Standards, located on the south side of Bois D'Arc Road and approximately 800 feet west of Jordan Road, with the following special ordinance provisions: use and development of the subject property shall conform to "PD" - Planned Development District Ordinance No. 2011-01-002, and as amended, except as follows: a maximum of 13 portable buildings be allowed on the subject property generally in the locations shown on the attached site layout; gates shall generally be placed in the locations shown on the attached fence exhibit; eight (8) Knock Out Rose shrubs and eight (8) Holly shrubs (2 feet at time of planting, placed 3 feet on center) will be planted along the south of the two proposed portable buildings; and two (2) Crepe Myrtle trees (spaced 10 feet apart, 5 feet tall, 2 inches in caliper at time of planting) and 8 Knock Out Rose shrubs (2 feet at time of planting, placed 3 feet on center) will be planted along the west side of the proposed storage building, shown on the attached site layout, with a vote of 5-0-1, Council member Pogue abstaining. Council member Pogue returned to the dais.

Mayor Pro Tem Ussery called for a Public Hearing to Consider/Discuss 14-125 on an Ordinance Granting Oncor Electric Delivery Company, LLC, a Non-Exclusive Franchise to Use Public Rights-of-Way for the Purpose of Constructing and Operating an Electric Distribution System. Financial Officer Rodney Rhoades stated that this is the second public hearing required by the City Charter for the franchise agreement with Oncor. The Ordinance addresses the concerns Council member Kever brought up at the last meeting regarding vegetation management. This is a 10 year agreement unless either party provides 60 day notice to the other party. Council member Kever stated that Mr. Rhoades receives a 30 day notification prior to Oncor trimming trees. Ms. Kever requested that the City Council receive a notification when the City receives the notice. Mayor Pro Tem Ussery called for public comment and there was none. Council unanimously approved the motion by Council member Pogue, seconded by Council member Harris, to close the public hearing 14-273

and approve an Ordinance granting Oncor Electric Delivery Company, LLC, a Non-Exclusive Franchise to use public rights-of-way for the purpose of constructing and operating an Electric Distribution System. Caption reads as follows:

Mayor Pro Tem Ussery called for Consideration/Discussion/Action Upon Adoption of a Resolution Determining a Public Necessity to Acquire Certain Property for Public Use by Eminent Domain for Right-of-Way (in Fee Simple) for the Construction Associated with the Stacy Road Elevated Storage Tank Project Located Along Stacy Road Approximately 2400 Feet East of Alma Road; Authorizing the City Manager to Establish Procedures for Acquiring the Right of Way (in Fee Simple) on Said Property, and Take All Steps Necessary to Acquire the Needed Property Rights in Compliance with all Applicable Laws and Resolutions. Director of Engineering Mark Hines stated that this is a tract that has been identified in our capital program for an elevated storage tank. Staff has contacted the property owner and made an offer. They made a counter offer that was way off. The City's plan is to negotiate and hopefully, come to a mutual agreement. Staff is asking tonight to use eminent domain, if necessary. Council unanimously approved the motion by Council member Harris, seconded by Council member Pogue, that the City of McKinney, Texas, City Council approve this item as written and

adopt the Resolution described in this agenda item and authorize the use of the power of eminent domain to acquire for public use all necessary right-of-way (in fee simple) from the owners of the property depicted on and described by metes and bounds attached to said Resolution, said depiction and description being incorporated in their entirety into this motion for all purposes including the construction, access, and maintenance of the Stacy Road Elevated Storage Tank located along Stacy Road approximately 2400 feet east of Alma Road. Caption reads as follows:
