APRIL 21, 2015

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on April 21, 2015 at 6:00 p.m.

Mayor Loughmiller called for Consideration/Discussion/Action on a 15-371 Resolution Authorizing the Interim City Manager to Submit a Proposal in Response to the 2015 Transportation Alternatives Program (TAP) Call for Projects and Accept Funding, if Awarded, from the Texas Department of Transportation (TxDOT) for a State Highway 5 Reconstruction Project. CIP and Traffic Manager Gary Graham stated that this Resolution authorizes the Interim City Manager to submit a proposal in response to the 2015 Transportation Alternatives Program (TAP) Call for Projects and accept funding, if awarded, from the Texas Department of Transportation (TxDOT) for a State Highway 5 Reconstruction Project. Staff is proposing the alternative cross section (with bike lane) to include in the TAP Call for Projects. Projects are ranked on improving safety, implementing active transportation and mobility plans, making local and regional linkages and connections, reducing barriers, providing environmental benefits and reducing congestion, and creating economic development opportunities. Staff is seeking Council approval to request \$3 million in 2015 TAP under Category 1 of the TxDOT TAP Call for Projects for the reconstruction of State Highway 5 between Standifer Street and Watt Street. The estimated construction cost for the SH 5 Reconstruction Project between Standifer Street and Watt Street is \$8.9 million. Per TAP funding requirements, the City would be required to

match a minimum of 20% of the total project cost (approximately \$2 million). However, to remain competitive, Staff is only seeking \$3 million in TAP funding and would overmatch approximately \$7 million to leverage the entire project. Council unanimously approved the motion by Council member Kever, seconded by Council member Day, to approve a Resolution Authorizing the Interim City Manager to Submit a proposal in response to the 2015 Transportation Alternatives Program (TAP) call for projects and accept funding, if awarded, from the Texas Department of Transportation (TxDOT) for a State Highway 5 Reconstruction Project. Council member Day thanked Mr. Graham for his work on Highway 5. Mr. Day stated that Highway 5 is an economically important corridor for McKinney. Our Gateway project feeds in to Spur 399/Highway 5, Wistron Corporation is on Industrial Boulevard that feeds into Highway 5, McKinney National Airport with Monarch Air and the Air Ambulance Company all feed into Highway 5 off Industrial Boulevard. The Cottonmill that has a number of corporations and is in the process of putting 66,000 square feet of additional premium office space which feeds into Highway 5. Downtown McKinney which is one of the best places in McKinney feeds off of Highway 5. Also along the Highway 5 corridor is The Flour Mill, Hisan Corporation, Tong Yang Group, Tupps Brewery and Franconia Brewery. When you look at economic development on the east side of Highway 75, we need to do anything we can to rebuild and redevelop along Highway 5 because it is good for McKinney. Mr. Day noted that this past weekend, downtown McKinney hosted the annual Juried Art Show. The show drew 150 entries from all over the state, with "Le Bleu Nuit" by Winston Lee Mascarenhas taking home the top prize for large-scale artwork. Mr. Day thanked MPAC/Main Street Director Amy Rosenthal for a fantastic job on the event.

Council member Kever did not have any comments.

Mayor Pro Tem Ussery thanked each and every staff member for what they do each and every day.

Mayor Loughmiller stated that this Friday is Relay for Life at the ball fields at Craig Ranch from 7:00 p.m. to 1:00 a.m. This is the 13th year for Relay for Life in McKinney and is a celebration and effort to raise money for cancer research and awareness. McKinney has consistently been one of the largest contributors to Relay for Life in the state of Texas with over \$4 million raised in 13 years. The money raised in McKinney does stay local. The event is expecting 3,000-4,000 people in attendance.

Interim City Manager Muehlenbeck stated the City Council's 2015 Legislative Priorities are on the city's website under the City Government section. There is an email link for citizens to contact your State Legislators. Mr. Muehlenbeck thanked CoCo Good for this concept. Mr. Muehlenbeck also noted that early voting for City Council starts April 27th and runs through May 5th. Polling locations are on the Collin County website. The City is hosting a garage sale and craft fair on May 2nd from 8:00 a.m. to
