

## **CITY COUNCIL REGULAR MEETING**

**FEBRUARY 2, 2016**

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on February 2, 2016 at 6:00 p.m.

- 16-143** Mayor Loughmiller called for Consideration/Discussion/Action on the Acceptance of the Comprehensive Annual Financial Report (CAFR) and the Federal and State Single Audit Reports for the Fiscal Year Ended September 30, 2015. Chief Financial Officer Rodney Rhoades stated that we are presenting the Comprehensive Annual Financial Report. Senior Financial Services Manager Trudy Mathis stated that the CAFR is our Comprehensive Annual Financial Report and is the financial statements and disclosure statements for all of the city's funds including the city's component units, MEDC, MCDC, Main Street and CVB. One change in reporting for FY 2015 is the Governmental Accounting Standard Board Pronouncement 68, which is the requirement for us to report the city's net pension liability on the face of our financial statements. It was previously reported in the note disclosure but did not affect the bottom line on the financial statements. Ms. Karen Curtain, Senior Manager with BKD, stated that the independent auditor's report on the basic financial statements included four reports: independent auditor's report on internal control, report on compliance for each major federal and state program, and report on internal control over compliance and report on schedule of expenditures, a federal and state awards required by OMD CIRCULAR A 133 and State of Texas Uniform Grant Management Standards. The City had a good year financially overall. Property tax and sales tax revenue were up as well as charges for

services and contributions. Expenditures were down primarily related to a legal judgment in 2014 which was not present in 2015. At the general fund level, revenues exceeded budget as a result of conservative revenue estimates and expenditures were below budget due to strong financial stewardship. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Branch, to accept the Comprehensive Annual Financial Report (CAFR) and the Federal and State Single Audit Reports for the Fiscal Year Ended September 30, 2015.

Director of Planning Brian Lockley stated that the applicant has requested that the public hearing be continued and the item tabled to the February 16<sup>th</sup> meeting. Mayor Loughmiller called for public comments and there were none. Council unanimously approved the motion by Council member Pogue, seconded by Council member Day, to continue the public hearing and table the item until the February 16, 2016 regular meeting.

**15-310Z2** Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "AG" - Agricultural District to "SF5" - Single Family Residence District, Located Approximately 1,500 Feet North of Virginia Parkway and Approximately 1,260 Feet East of Lake Forest Drive, and Accompanying Ordinance. Director of Planning Brian Lockley stated the applicant is requesting to rezone 33.28 acres of land from AG to SF5 for developing the site with

single family residential development on Lake Forest just north of McKinney Boyd High School. Staff met with the applicant and is working toward a required second access for this site. One of the issues that will be performed in the platting of the property is the drainage and the amount of flood plain on the property. During the Planning and Zoning Commission hearing, residents expressed concern about the development. There is a creek that was platted as part of West Creek Estates and there is also a preservation zone that will have to be maintained which is a minimum of 15 feet for all quality trees along the edge. The applicant will be developing this site with single family residential but that is not going to occur until the engineering is completed and they have a better understanding of how many lots can be developed on the site. As part of the subdivision regulations, they would have to reach out and speak to McKinney ISD to allow additional access to the property. The tree requirements for the tree preservation zone would require them to maintain a minimum of 15 feet from all quality trees located along the fence line. As part of the tree preservation, they can only remove up to 30 percent of the quality trees that are in the flood plain. Anything beyond that would require an approved variance by City Council. They would have to address all those areas during the platting and development of the site. In regards to drainage, the Ordinance does not allow anybody to make changes that will effect anybody else in the flood plain. As part of the drainage study, if it comes back that on-site retention needs to be developed then they would be required to do so. Applicant Melissa Lynlo, 500 Main Street, Suite 800, Fort Worth, representing the property owner, stated that they are requesting single family 5 zoning on the property which is compatible with the comprehensive plan. When we go to develop the property through the platting process, the City's drainage Ordinance will be enforced. We cannot increase the flood level, we have to maintain or decrease it, and

we have to put all of our drainage into a city system. If there is no capacity in the city system, we will have to retain on site. The project to the northwest that was just rezoned for SF5, has committed to provide access through their subdivision as a condition of their zoning approval. They will be moving forward with platting fairly soon and will show that access point on there. The second point of access would likely be through the school site if we can work out all the details, if not we'll look for a second point of access somewhere else. It won't be across the creek and through the subdivision to the east. Our preliminary engineering studies show there are 8 acres out of the 100 year flood plain and there is additional opportunity to do reclamation adjacent to that. Mayor Loughmiller called for public comments.

Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to close the public hearing.

Mayor Loughmiller stated the one authority that we have as a Council on zoning issues is the ability to require certain things to happen before that zoning is put in place. I feel the process is backwards on this case. The other issue I have is ultimately we get a rezone based on a fiscal impact study that shows presumed value based on existing zoning and proposed zoning. This property is based on the ability to develop 33.28 acres which has not been answered. Even at full development, there is a net



loss in terms of cost benefit to city services for this development. Council approved the motion by Council member Pogue, seconded by Council member Rogers, to approve an Ordinance rezoning the subject property from "AG" - Agricultural District to "SF5" - Single Family Residence District, located approximately 1,500 feet north of Virginia Parkway and approximately 1,260 feet east of Lake Forest Drive, a vote of 5-2-0, Mayor Loughmiller and Mayor Pro Tem Usery voting against. **16-144** Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Selection of a Location for the First City-Sponsored Public Art Mural. Housing and Community Development Manager and McKinney Arts Commission Liaison Janay Tieken stated this item is a public hearing on the location for the first City sponsored art mural. The artist and design for the mural were selected by the McKinney Arts Commission from eight

submissions. The original site approved for the mural was the Cadillac Pizza building. The Chamber building at 400 West Virginia was also identified as a potential location for the mural. The Arts Commission met on January 21, 2015 and kept the original recommendation of the Cadillac Pizza building if Council will allow the Arts Commission to take the \$6,400 repair cost of the building from the public art fund without a match. The Arts Commission is recommending both the Chamber and the Cadillac Pizza site. Mayor Loughmiller called for public comments and there were none. Council approved the motion by Councilwoman Rath, seconded by Council member Branch, to close the public hearing and approve the \$6,400 for the wall repair of the Cadillac Pizza site from the City funded portion of the public art fund without a 50% match from private funds for the repair and approve the original site of 112 S. Kentucky (Cadillac Pizza site) with a vote of 6-0-1, Council member Day abstaining.

Council member Day returned to the dais.

- 16-145** Mayor Loughmiller called for Consideration/Discussion/Action on an Ordinance Amending the Fiscal Year 2015-2016 Annual Budget to Provide Funds for Two Part-Time Parking Enforcement Officers and Equipment Under the Direction of the McKinney City Marshal. Municipal Court Administrator Gilbert Hernandez stated that this item is appropriation of \$38,977 from the general fund for two part-time parking enforcement officers that will be under the direction of the City Marshal. If approved this program is to enforce parking near and around the downtown square, Monday through Friday from 8:00 a.m. to 5:00 p.m. Communication will be provided to business owners and community members through the City's website and other social media starting February 8<sup>th</sup>. Warnings will be issued starting approximately March 22<sup>nd</sup> with the enforcement estimated to begin on April 4<sup>th</sup>. The citation cost for three-hour parking violation is \$42 with \$17 sent to the state and \$25

retained by the City. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Day, to approve an Ordinance amending the Fiscal Year 2015-2016 Annual Budget to provide funds for two part-time Parking Enforcement Officers and equipment under the direction of the McKinney City Marshal. Mayor Loughmiller called for Citizen Comments and there were none.

Mayor Loughmiller called for Council and Manager Comments.

Council member Rogers did not have any comments.

Councilwoman Rath did not have any comments.

Council member Branch stated that he looks forward to the City moving forward as we look for a new City Manager. I want us to work together to give good direction overall.

Council member Day did not have any comments.

Council member Pogue thanked the people that came out tonight to speak on the zoning case that was a split decision. I encourage all citizens to get engaged in the process in what we do. Thank you for your participation and interest. Mr. Pogue asked Mr. Muehlenbeck to consider looking at the lighting within the constraints of the ball fields for those particular citizens in that area.

Mayor Pro Tem Ussery thanked Minshew Elementary for having him come look at the self-made roller coasters created by first graders. It is amazing what an uncluttered mind can create. It was very rewarding and glad to be at Minshew. Mr. Minshew was his Principal in junior high and his Assistant Principle in high school. Mr. Ussery expressed his condolences to the family of Mr. Willie Wattley. Mr. Wattley was the epitome of public service, representing people but not to the detriment of anyone that disagreed with him. He was a shining example of how we should represent ourselves. A final thank you to our Finance Director Mr. Rhoades. His financial skills were probably less loud than the clothes he wore. We will miss his presence. Thank you staff for what you do day in and day out for making this the number one place to live in the nation.

Mayor Loughmiller echoed the comments about Willie Wattley. Mr. Loughmiller stated that he attended his funeral Saturday. Mr. Wattley served on City Council 24 years, he was Mayor Pro Tem for 18 of those 24 years, and involved in a number of organizations in the City of McKinney and in the County. One comment that one of the Pastors said in his speech: "Willie Wattley lived a life of meaningful longevity". I think that hit me because he lived to be 91 years old and passed on his birthday as he made good use of that 91 years. My condolences to his family. The other item I would like to talk about is getting back to city government and procedurally how we move forward. We have a policy which I think is a good policy that two council members can bring agenda items forward. I would like to add to that, with the Council's consensus, one thing I think Council comments affords us is the opportunity to speak to the Council as a whole about issues or items that you feel need to be addressed. The caveat to that from a planning standpoint would be just to work on the timing of when something hits an agenda. I would like to try, if Council agrees, that in Council comments if there is an issue that you feel needs to be addressed on behalf of your constituents or something you feel you would like the staff to address generally in the form of a future agenda item at some point, I think it would be healthy to do that because it gives us the opportunity to chime in if we want to do that or not. That gives Mr. Muehlenbeck or whoever is the future City Manager the opportunity to hear from all seven of us about things that are important to the Council as a whole. Having served with the new people since June, I have confidence that we can continue to work as we have been and think that will make our communication and transparency better than it already is.

Interim City Manager Muehlenbeck stated that there was a system glitch with our IT server and some e-mails with electronic utility bills were sent out in error. We will manually resend some 639 e-mails with the correct information. We want to let the citizens know all the data is safe and secure.

Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to adjourn. Mayor Loughmiller adjourned the meeting at 8:20 p.m.
