17-065 Mayor Pro Tem Pogue called for Consideration/Discussion/Action on a Resolution Approving the Concerted Revitalization Plan to Assist in the Redevelopment of McKinney Housing Authority Properties. Housing and

Community Development Manager Janay Tieken was present to answer any questions. Ms. Tieken stated this item will allow the Merritt, Lloyd Owens and Cockrell properties to be competitive for 9% tax credits. If they were not competitive for 9% tax credits, they would have to apply for 4% and would need a great deal of subsidy in order to redevelop the properties. This will bring outside equity into our community for the redevelopment of these properties. The Housing and Community Development Department has already completed many of the requirements to revitalize that area including the Town Center Plan, the TIRZ 1 District, and the updated Comprehensive Plan so we will be using initiatives that have already been started. The zone will allow the developer to apply for 9% tax credit and score enough points on their application to be competitive to get the credits. Without the Concerted Revitalization Plan they would not be able to score high enough because this is not a high opportunity area. This is an alternative to the high opportunity area scoring. City Council can select one project per year as most contributing to economic benefit. If Council decides to do that, they get an extra two points on the application. Consideration of Merritt homes is next in line and they are scheduled for the February 7th Council meeting. Council unanimously approved the motion by Council member Day, seconded by Council member Branch, to approve a Resolution Approving the Concerted Revitalization Plan to Assist in the Redevelopment of McKinney Housing Authority Properties. Director of Strategic Services Chandler Merritt stated this is the next step in procuring funding for public transit in McKinney and the larger area. This is the state's side of the funding and is a contract with the Texas Department of Transportation. After we meet with the Urban Transit District, we will bring back an additional item for a Program Grant Agreement which would give more detail on the level and types of transit that would be provided. The timeline and history of this item is on the City's website on the FAQ section. Execution of the Master Grant Agreement (MGA) gives the City of McKinney the ability to apply for transit grant funds from the Texas Department of Transportation - Public Transit Division (PTN). The MGA covers a period from the date of execution through August 31, 2021. A Project Grant Agreement (PGA), outlining services to be provided, recommended service provider, and budget will be brought back to City Council for approval, after a recommendation is made by the McKinney Urban Transit District. This item only deals with the TxDOT agreement, which is the state grant funds. For fiscal year 2017, the state grant is approximately \$312,000. On the federal side, we are currently using fiscal year 2016 allocation and it is approximately \$2.5 million for the McKinney urbanized area. This amount is annual and depends on the appropriation given by Congress. The federal money is a matching system, for every dollar you put in you get a dollar. The \$312,000 can be used as a match should we have direct recipient status to pull down another \$312,000 from the federal government. Staff is working on a draft budget now to present to the City Council and the Urban Transit District proposing one full-time staff member, which would be paid out of the state grant funds with no cost to the general fund or operating funds. Mr. Merritt stated that the City has been working in tandem with the North

Central Texas Council of Governments through the entire process and they have offered their service to assist us in anything we need from the transit related side to ensure all our processes are set up. The next step would be to convene the Urban Transit District. It's our intent to have several transit authorities who wish to offer transit services be at that meeting. We hope to get direction on levels and types of services so staff can work on procuring the services. Mayor Pro Tem Pogue noted that he has stated before that he does not believe it's the actual role of government to provide public transportation, however, it is a quality-of-life issue. We must do this within a constraint of what we can afford to do as opposed to having a transit authority dictate or mandate our costs. Council unanimously approved the motion by Councilwoman Rath, seconded by Council member Rogers, to approve a Resolution authorizing the City Manager to submit a Master Grant Agreement (MGA) between the City of McKinney and the Texas Department of Transportation allowing the City of McKinney to apply for grant funds for Transit Service Provision. Mayor Pro Tem Pogue called for Consideration/Discussion/Action on a Resolution Approving the Submittal of a Formal Request to Federal Transit Administration (FTA) to Replace Texoma Area Paratransit Services (TAPS) Direct Recipient Status and Request that the City of McKinney be Appointed the Recipient for the McKinney Urbanized Area (MUZA). Director of Strategic Development Services Chandler Merritt stated this a companion item to the previous agenda item. This is a request to the Federal Transit Administration to formally name the City of

McKinney as the direct recipient for urbanized area funding. Mr. Merritt stated that officially TAPS is still the direct recipient of funding until someone else is named. At one time it was considered the North Central Texas Council of Governments (NCTCOG) would be the direct recipient and McKinney would be a sub recipient. The City decided it would be best if the City of McKinney be the direct recipient with support from the NCTCOG on the administration side. The City has to be named direct recipient with pre-award authority before we can draw down any funds. Regarding the issue of traffic backing up on Virginia, the school will not have designated drop-off and pickup times. Along with the large parking areas and the long drive, there is ample space for the traffic flow. Mayor Pro Tem Pogue called for public comment and there were none. Housing and Community Development Manager Janay

Tieken stated that the application process at TDHCA opens the first part of January and the Resolutions of Support and application are due to TDHCA on March 1st. For the Sphinx at Throckmorton project, they originally came before City Council on December 6th to request support or no objection to a 4% tax credit. They were going to need additional funds to make the project work and have decided to go after the 9% tax They are before City Council this evening requesting a credits. Resolution of Support for their development. Applicant, Mr. Jay Oji, Sphinx Development, 3030 LBJ Freeway, Suite 1350, Dallas, stated they are requesting support from the City Council for the 124 unit apartment complex fronting on Highway 380. Mr. Oji stated they are seeking approximately \$2 million from TDHCA to make the deal work better. They are not competing with the McKinney Housing Authority in any way and are asking for Council's support. This is a mixed-use development with 14,000 square feet of retail space on the ground floor fronting on Highway 380. There will be units targeted to the general public at market rate and expect those to rent for \$1,000 per month. The rest of the units will be targeted as affordable income units with adjusted rate rent at 30%, 50%, and 60% of market rate. Mr. Oji stated that they will not be asking the City of McKinney for any funds, however, the project is located within a TIRZ so whatever you do typically for projects in the TIRZ, we will come back and ask. If the City supports the project, an application will be filed with TDHCA in March and if awarded the tax credits, construction should start by the end of the year. Mr. Oji stated they will come back with a zoning request to rezone from residential and industrial/commercial use to a planned development that incorporates the two zones. Staff has been working with Mr. Oji on the zoning based on the original application filed for the 4% tax credits. Mayor Pro Tem Pogue called for public comments.

Mr. Victor Lissiak, 4205 Beltway Drive, Addison, stated he is the

consulting engineer. He stated the bridge is a truck-weighted bridge that connects the two sides of the development on either side of the 100 year floodplain.

Mr. Gerald Carlton, 24 Lakeside Park, Dallas, stated his organization is certified as a redevelopment organization to assist in the revitalization of communities.
