17-466 Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on the Request by the North Texas Municipal Water District ("NTMWD") for a Grant by the City of McKinney of a Water Line Easement Under and Across Public Land Owned by the City that is Designated as Parkland, Which Parkland is Generally Located South of US 380 Between Airport Boulevard and New Hope Road, for the Construction and Installation of Water Transmission Lines for the Mutual Benefit of NTMWD and the Public and Accompanying Ordinance. Director of Engineering Mark Hines stated that the North Texas Municipal Water District has requested that the City allow it to use portions of City designated parkland as permanent water line easements for the construction and installation of treated water transmission lines to provide treated water capacity to member cities and customers along the US Highway 380 corridor. The North Texas Municipal Water District needs to extend a transmission line from its current terminus on Airport Drive in order to service the City's proposed pump station on the corner of Bloomdale and Redbud that will provide water to the northern part of the City. They will also be branching off of that line to the East to serve parts of eastern Princeton. State Law requires that a municipality may not approve any program or project that requires the use or taking of any public land designated and used prior to the arrangement of the program or project as a park unless the municipality, acting through its duly authorized governing body or officer, determines that there is no feasible and prudent alternative to the use or taking of such land; and the program or project includes all reasonable planning to minimize harm to the land, as a park, resulting from the use or taking. State law does require that any time a City uses park property for anything other than the park that they have to conduct a public Mr. R. J. Muraski, Assistant Deputy Director for Planning for hearing. North Texas Municipal Water District stated that one of the projects will help feed a fourth delivery point for the City of McKinney as well as provide treated water to the City of Princeton. This project will take the line from the current area up to the proposed delivery point number four at Redbud pump station. The existing conditions are two current easements in the area. The first is an existing 14 inch water line that runs through the recently purchased park land and currently feeds Princeton. There is a wastewater conveyance easement that the City of McKinney sewers flow through with a lift station that NTMWD maintains. The bigger issue is in the future, if we put this 30 inch line in we believe we would be able to abandon it in the future so there would be no presence or need for the district to maintain the pipeline. The only impact to the park would be along the existing easement. It is more expensive, but does keep us on track to deliver on schedule and meet the demands and needs for both McKinney and Princeton. When we get the Lower Bois d'Arc reservoir online and get the treatment plant in Leonard

operational, that would allow us to get another delivery point to Princeton so that would allow us to abandon the 14 inch line if we go with option five. This is the option we recommend. It is anticipated that we will be able to treat water out of the Leonard plant and start delivering water from the Lower Bois d'Arc Reservoir in 2022. The original schedule was to have construction begin in 2020 but due to delays in permitting, we are not able to do that. Mayor Loughmiller called for public comments and there were none. Council unanimously approved the motion by Mayor Pro Tem Pogue, seconded by Council member Branch, to close the public hearing and approve an Ordinance granting the request by the North Texas Municipal Water District ("NTMWD") for a grant by the City of McKinney of a Water Line Easement under and across public land owned by the City that is designated as Parkland, which Parkland is generally located south of US 380 between Airport Boulevard and New Hope Road, for the construction and installation of water transmission lines for the mutual benefit of NTMWD and with option number five as evidenced in the presentation. **17-074Z** Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on

a Request to Rezone the Subject Property from "C" - Planned Center District and "CC" - Corridor Commercial Overlay District to "C3" -Regional Commercial District, "LI" - Light Industrial District and "CC" -Corridor Commercial Overlay District, Located Approximately 1,040 Feet South of Bloomdale Road and on the East Side of U.S. Highway 75 (Central Expressway), and Accompanying Ordinance. Director of Planning Brian Lockley stated the applicant is requesting to rezone 3.9 acres Tract A to C3 Regional Commercial and the 4.23 acres on the east Tract B, to Light Industrial for office and office warehouses uses. The commercial overlay district allows for increased height as well as increased architectural standards and does not affect the uses. The existing commercial uses will allow for banks, department stores, drug stores, food stores, office buildings, office uses, office supplies and the like. Those same uses are consistent with what's being proposed with the proposed C3 zoning. Applicant, Mr. Bob Roeder, 1700 Redbud, Suite 300, stated that the party that has the contract is a local HVAC company specializing in renovations of large buildings and systems. The reason for the split in the property is to allow them to build their office facility with the warehouse and some storage on the McLarry Road side which is recognized in your Future Land Use Plan as light industrial and will allow them to build office building on the Highway 75 frontage. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Ussery, seconded by Council member Rogers, to close the public hearing and approve an Ordinance rezoning the subject property from "C" - Planned Center District and "CC" - Corridor Commercial Overlay District to "C3" -Regional Commercial District, "LI" - Light Industrial District and "CC" -Corridor Commercial Overlay District, located approximately 1,040 feet south of Bloomdale Road and on the east side of U.S. Highway 75 (Central Expressway). Mayor Loughmiller called for Consideration/Discussion/Action on a 17-467 Resolution Authorizing the City Manager to Execute a Chapter 380 Economic Development Program and Agreement with Aimbridge Hospitality, LLC for the Resort Hotel at Craig Ranch. Assistant City Manager Barry Shelton stated this is the Chapter 380 Agreement for the resort hotel discussed at the last meeting. Aimbridge Hospitality intends to build and operate a resort hotel on the northeast corner of Collin McKinney Parkway and Van Tuyl Parkway. The agreement tonight sets forth the terms of the economic incentives and grants provided by the City to this project. The agreement does require the hotel to be branded as the Marriott Autograph Collection and requires a minimum of 285 guestrooms and 33,000 square feet of meeting and conference space. On-site amenities required are a resort style pool with lazy river, fitness center, concierge, three meal restaurant as well as other amenities as discussed previously. The Chapter 380 agreement is just for the City's portion of the incentive package. It's up to \$10 million in tax reimbursements over 10 years. Years one through five, the City will reimburse 75% of the sales tax, property tax and hotel occupancy tax to the project. Years six through 10, it will drop to 50% and will not exceed 10 years or \$10 million. There is no upfront cash or general fund money being spent on this project. These are dollars that will be reimbursed out of the taxes generated from the development of the property. McKinney Community Development Corporation approved the terms at their meeting last week for their portion of the grant, or incentive package, which includes \$5 million in a loan at commencement of construction and a \$3 million grant at the time of Certificate of Occupancy. The key points on the financial impact, based on various projections, notes that the \$5 million loan and \$3 million grant from the MCDC will be repaid through loan payments and City tax collections in seven to eight years from the opening of the hotel. Based on the same projections, the total package of money will be earned back by the City within 10 to 13 years. Important to note, the first year of operation of the hotel, after all of the incentives given back in reimbursements, we estimate will generate \$350,000 in tax revenue back to the City. That's a combination of hotel occupancy tax, ad valorem property tax and sales tax. Based on our projections, at the end of the 10 year incentive period we anticipate the hotel will bring in approximately \$2 million per year in additional City taxes. The MCDC \$5 million loan has to be repaid at year eight after opening the hotel or upon sale or refinance of the property. If Marriott were to sell to another operator, they would be required to take proceeds from the sale and repay that loan. If the hotel is sold, the City's incentive package would go with the sale of the property and those incentives would be available to the new owner. Applicant, Mr. Bob Roeder, 1700 Redbud, Suite 300, McKinney, stated that the Marriott Autograph Collection is a 20-year franchise from Marriott and cannot be broken. If the property were to change hands, that flag would stay in place for at least 20 years. One of the things we agreed to in the 380 agreement is that flag will have to remain for the entire term (10 years). Mr. Shelton stated that the estimates we have for construction value or cost of construction are \$100 million for this project. So for a \$100 million project our cash portion is

only \$3 million in grant money. When you look at the loan being repaid at 3% interest annually, it works out to be about \$1.5 million in total outlay of cash once the loan is paid back. Council unanimously approved the motion by Council member Rogers, seconded by Council member Branch, to approve a Resolution authorizing the City Manager to Execute a Chapter 380 Economic Development Program and Agreement with Aimbridge Hospitality, LLC for the Resort Hotel at Craig Ranch. The key changes to the agreement are: Market data being defined as average pay of benchmark cities plus 1.5%; Market surveys and any corresponding adjustments will now occur twice annually on January 1<sup>st</sup> & April 30<sup>th</sup>; duration of the contract changed to four years (the agreement terminates on September 30, 2021); maintained rollback election termination option if no agreement after 60 days on a modified agreement; a new Personal Floating Holiday has been added to the agreement and we are looking at doing the same thing for our general employees starting October 1<sup>st</sup>; streamlined Sick Leave Payout process; and made other compensation adjustments to On-Call Pay, Special Events Pay, and Holiday Buy Back minimums. Previously there was a 365 days' notice of retirement for 100% sick leave payout and that was becoming cumbersome for people to prepare that far out so we reduced it to a 30-day notice to receive their 100% sick leave payout. We did

maintain the no lockout, no strike and we continue to maintain the management rights. We have a really good vision from the City Manager to deal with the Police Department and that set the tone for open communication. Council unanimously approved the motion by Council member Branch, seconded by Mayor Pro Tem Pogue, to approve a Resolution ratifying the Third Meet and Confer Agreement with the McKinney Police Association. Caption reads as follows:

RESOLUTION NO. 2017-05-103 (R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, RATIFYING THE THIRD MEET AND CONFER AGREEMENT WITH THE MCKINNEY POLICE ASSOCIATION

Mayor Loughmiller called for Consideration/Discussion/Action on 17-469 Appointing a Member to the North Texas Municipal Water District Board. Mayor Loughmiller stated this appointment is done every two years. We are currently served by Joe Joplin and Charles McKissick on that Board. There has been a lot of activity going on at the water district over the last year. As we work through issues related to the water district rates and calculation of usage, the City of Plano and others have requested intervention by the Public Utility Commission. Several cities, McKinney included, are not in support of this. We believe any modifications to the current system recommended will cost the City of McKinney residents more than what it costs now. There hasn't been a proposal recommended that would be beneficial to McKinney. Mr. Joplin and Mr. McKissick have both served the City for a long time and both in leadership roles. From my standpoint, I recommend we reappoint Joe Joplin to the Board for this two-year term because of the ongoing issues and the potential of having to appear before the Public Utility Council unanimously approved the motion by Council Commission. member Ussery, seconded by Council member Rogers, to appoint Joe Joplin to serve as a Director to the North Texas Municipal Water District Board starting June 1, 2017 and ending May 31, 2019.
