Mayor Fuller called for Council and Manager Comments.

Mayor Fuller stated that the development agreement that was sent out would have to be approved by Council and that would happen once we determined what the vote on the annexation was. There are no agreements in effect at this point. We just terminated annexation. Council will be discussing a development agreement that we hope to offer to ETJ residents that will come after speaking with residents, holding some open forums where we can have a constructive dialogue back and forth. I think the benefit to ETJ residents is if property laws change again you will not be annexed and it ensures the best use for McKinney in the future as a whole.

Council member Philips thanked the McKinney Lions offensive line for opening holes big enough for running back Matt Gadek to rush for 599 yards setting a state record. Awesome work by the entire team and congratulations to Matt Gadek and the McKinney Lions.

Council member Elliot thanked everyone who has attended. I realize our attendance has been just slightly up over the last few weeks. We would love to have every one of our meetings this well attended. I want to thank City staff for getting the

quality of the audio and the video done. I cannot tell you how happy we all are to be back on our home turf. I was uncomfortably close to Rainey and Charlie when we were in the Commissioner's Court. We're not small so it was tough to get elbow room in there. Last night I talked about volunteer organizations and how they are what make McKinney McKinney. So I just want to take a short moment to highlight a different organization each meeting. The order does not reflect priority, nor does it infer importance. There is a group called the Community Garden Kitchen. This is a group that is currently fundraising to build a kitchen on the grounds of Holy Family School. I'd just like to read a couple of things off their website. To be a center of hope and compassion ensuring that no one in our community suffers the fear of food insecurity. To serve nutritious meals to those in need in a safe, welcoming place. To design a multi-use facility which will be shared by the school and CGK as a place to prepare and serve meals. The building will also be home to community meetings and instructional classes in food preparation, nutrition, and health. This is a meal that's not like perhaps a common picture of what a soup kitchen would be like. The goal of Community Kitchen is to have the folks that are in need come have a meal, sit down, get to know folks, and be served in the way that we would all like to be served. So I just want to shout out to Community Garden Kitchen. The website is communitygardenkitchen.org. Although she would not seek or ever want this kind of publicity, Angela Poen is the driving force. She has this as her full-time and definitely non-compensated job to lead this effort in fundraising. So shout out to McKinney Community Garden Kitchen.

Mayor Pro Tem Rogers stated that when we were first approached about the annexation process, it was all kind of new to us. So we voted, the majority of us voted to move forward with it. I think it's been a great process. I think it's been a learning process for us and the community. I'm also reminded how people were talking about the City of McKinney, it's un-Texas, it's un-American to annex. And the state of Texas even recognizes that, but one of these days TxDOT is going to come knocking on people's door ready to take your land because of some bypass. We don't know where that bypass is coming. We don't know when it's coming, but ultimately it might come. Just be aware, the state of Texas didn't give up the right to eminent domain on a property. The City of McKinney has nothing to do with that. We can say this is where

we want it but ultimately it's their decision and their decision only. If that happens, you have to know that the City of McKinney doesn't have any say in that. Sometimes eminent domain means we have land taken from the City of McKinney or things put in the City of McKinney that maybe we don't necessarily want but because of that eminent domain, it's done. I don't know when that's going to happen, but that's eventually going to happen, probably in the next five to ten years. It's been a pleasure to meet so many of you that have taken the time to come and voice your opinions and your thoughts. I've appreciated the process.

Council member Shemwell noted that as the first motions were going, I was making the motions. That's because of my youthfulness, I understand electronics. To the ETJ residents, I thank you, I applaud you. This is what democracy looks like. This is the power of the people. This is what I ran for. The voices of the people when you stand strong, unite. This is what this country is founded on. I applaud you in your victory tonight. I don't think I'll ever look at red the same again, so this Christmas will be interesting, but thank you. Dominique Alexander, Next Generation Action Network. I agree with you. I agree with you. And to Dejerria Becton, I am sorry and I truly apologize. Had a grown man assaulted my daughter like that, we'd be having a much different conversation. It's time to get this past because McKinney is rising and moving forward. It's time to put the past behind us and get this squared away and taken care of. Thank you for all that you do. This also is what democracy looks like, so keep doing what you're doing. It has been an interesting last few weeks. I've sat down with a lot of people, met a lot of you, and I enjoyed those opportunities. Thank you for hearing me and allowing me to hear your voices. This is why we ran, what we're here for. I have no agenda myself. I come here every week and see what's on the agenda. I do what I think is best when I hear the concerns of the residents that I represent. There's nobody pulling my strings. There's nothing personally that I want other than to make our City a great place. So thank you for that opportunity. Hopefully we see you guys next week and all the other weeks so that we're not just talking to empty seats. Makes it much more exciting to see you all.

Council member Branch stated that in the last few weeks I've gotten to meet a lot of great people that are out in the ETJ. A lot of great, hard-working, honest people. I've

grown up in a large city most of my life, Richardson, Dallas and then here in McKinney. Even though the acres separate you, it seems like you all work together as a community better than some large cities. I certainly admire that about you. You brought some of those principles here with you. I really appreciate the opportunity to get to meet and understand more about each and every one of you all. I appreciate this opportunity to serve you all with our decisions.

Councilwoman Rath noted that Veteran's Day is Saturday. In McKinney, you've got a lot of ways to honor our veterans. At 9:00 a.m., Ross Cemetery is having a ceremony. At 11:00 a.m. at the Veteran's Memorial Park in Craig Ranch there will be a ceremony. The Collin County History Museum is having a special event in an incredible exhibit there from 12:00 p.m. to 2:00 p.m. At sundown at 5:26 p.m. back at the Veteran's Memorial Park. I'm going to be attending those events and hopefully, you will be able to plug into one or more of those events as we honor and celebrate our veterans.

Mayor Fuller thanked Council member Phillips who is here today after a shoulder surgery just hours ago. Also, I just want to own it right now that when my kids ask me how my birthday was, I'm going to say, 150 people came to my party tonight and it was very festive. They all wore red T-shirts to show unity.

17-254Z Mayor Fuller called for a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "AG" - Agricultural District to "C1" - Neighborhood Commercial District and "C2" - Local Commercial District, Located at 1301 North Custer Road, and Accompanying Ordinance. Planning Manager Samantha Pickett stated the applicant is requesting to rezone the property to two commercial districts. It will be split approximately with 1.5 acres in the front and the remainder in the back of the 7-acre tract. The front portion will be C-2 which is slightly more intense commercial district, whereas the remainder will be C-1 which is our least intense commercial district. The property is currently zoned for AG, however there is a vet clinic commercial use on the front of the property that will continue to stay there moving forward. Given the

current use of the adjacent commercial properties to the north as well as the size and access that's limited to this property, staff is recommending approval of this request. The vet clinic will be a non-conforming grandfathered use and they can continue operating as long as they don't expand. Applicant Mr. Dwayne Zinn, Cross Engineering Consultants, 131 S. Tennessee, McKinney, was present to answer any questions. Mayor Fuller called for public comments and there was none. Council unanimously approved the motion by Council member Shemwell, seconded by Mayor Fuller, to close the Public Hearing and approve an Ordinance rezoning the Subject Property from "AG" - Agricultural District to "C1" - Neighborhood Commercial District and "C2" - Local Commercial District, located at 1301 North Custer Road. McKinney Economic Development Corporation President Darrell Auterson stated that we are operating under the Memorandum of Understanding that was approved back in April of this year on the Southgate property. We're transitioning into what's known now as the land JV phase of the proposed Master Development in Marketing Agreement. This Agreement was approved by the Board of Directors of the McKinney Economic Development Corporation at their October 17th meeting and has been executed by the development partner members. We are seeking Council's ratification of the Agreement tonight and we'll be seeking ratification from the McKinney Community Development Corporation Board at their meeting next week. Mr. Auterson stated that the Board unanimously voted to support this current version of the Agreement except one member who was absent from the meeting. Council approved the motion by Councilwoman Rath, seconded by Mayor Pro Tem Rogers, to approve the Southgate McKinney Master Development Agreement with a vote of 5-2-0, Council member Philips and Council member Elliott voting against.

Mayor Fuller called for Consideration/Discussion/Action on a Resolution Authorizing the City Manager to Execute a Developer Participation Agreement with SLC McKinney Partners, L.P., for the Construction of an Oversized Wastewater Main and Related Infrastructure Improvements, Being Extended to the Tucker Hill, Phase 4 Subdivision, Generally Located East of Tremont Boulevard and North of Darrow Drive. Director of Engineering Gary Graham stated this is discussion on Phase 4 of the Tucker Hill development. As part of this phase, they need to extend their sanitary sewer roughly 1,700 feet. They are only required to install a 12-

inch line, however, this is a master plan line and needs to be a 24-inch The estimated cost for the total line is \$235,000 and our line. participation is estimated to be just over \$147,000 at this time. Graham stated that the City requires the developer to prepare an estimate for the cost of the 12-inch line and an estimate for the cost of the 24-inch line. Any difference is the amount paid by the City. Mayor Fuller stated that the reason the City pays is because we're interested in a line that has increased capacity for the development that happens beyond that. So right now we can piggyback on the job that they're already doing and just pay an incremental cost to increase the line and capacity. Going from a 12-inch to 24-inch is not a pro rata increase, it's an exponential increase. But the reason why we would do it is to provide capacity for future development so we're not coming in down the road and redoing an entire line ourselves. Council approved the motion by Council member Shemwell, seconded by Mayor Pro Tem Rogers, to approve a Resolution authorizing the City Manager to execute a Developer Participation Agreement with SLC McKinney Partners, L.P., for the construction of an oversized wastewater main and related infrastructure improvements, being extended to the Tucker Hill, Phase 4 Subdivision, generally located east of Tremont Boulevard and North of Darrow Drive with a vote of 6-1-0, Council member Philips voting against. L.P. Director of Engineering Gary Graham stated this item is a

modification of the Annexation Facilities Agreement that was executed with Auburn Hills Partners. When Auburn Hills development came in, they bought a piece of land. We had a proposed alignment of Ridge Road that hadn't been fully studied. As they were going through their development process, we did an alignment study of Ridge Road from Wilmeth to U.S. 380. We were also working with an adjacent development with constraints of that development and the Stover Creek, Ridge Road and Wilmeth intersection. We actually adjusted the alignment of Ridge Road and pulled it away from Auburn Hills. decreased the frontage of Ridge Road along their property, which decreased their required participation in the construction of Ridge Road due to the subdivision regulations. With that reduction, from 2,226 feet to 926 feet, they were going to receive single-family development roadway impact fee credits for that portion of the roadway. Because we decreased the number of linear feet that they have to construct, it also decreases the amount of impact fee credits they receive. This allows them to escrow the money, receive impact fee credits, and decrease the amount of impact fee credits they receive based on their new participation amount. Council approved the design contract about two meetings ago and that is about a year-long design contract. We have the money set aside for the construction of that as well and this \$330,000 will go towards that as well. Council unanimously approved the motion by Council member Elliott, seconded by Mayor Pro Tem Rogers, approve a Resolution authorizing the City Manager to execute a First Amendment to the Auburn Hills Annexation Facilities Agreement with Auburn Hills Partners, L.P.
