JANUARY 15, 2019

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers at McKinney City Hall, 222 N. Tennessee Street, McKinney, Texas, on January 15, 2019 at 6 p.m.

Mayor Fuller called for the following Regular Agenda and Public Hearing items:

19-0017 Consider/Discuss the 2019 Citizen Bond Committee's Recommendations for a May 2019 Bond Election. City Manager Paul Grimes spoke in the

absence of Assistant to the City Manager Trevor Minyard (Bond Committee Coordinator) stating the Committee consisting of a diverse group of citizens met on four different occasions to discuss and ask questions concerning staff-proposed projects to be built over the next 5-10 years. The purpose of the Bond Committee was to share differing perspectives, provide financial oversight and submit recommendations to Council. Mr. Grimes stated the Committee members contributed a collective 250 volunteer hours.

Former Mayor Brian Loughmiller, 6305 Wildwood Drive, McKinney 75072 spoke representative of the Bond Committee providing an overview of improvement needs of the City across different areas valued at \$350 million: Public Works Facility (\$34 million), Public Safety (\$75 million), Municipal Community Complex (\$50 million), Parks Facilities (\$91 million), and Transportation (\$100 million). Mr. Loughmiller stated the City must respond to a growing population and aging facilities and actual infrastructure needs for future development exceed the final recommendations – the initial project list totaled \$450 million; however, the recommendations would allow to City to prioritize and make significant accomplishments without increasing taxes and will allow additional future debt capacity; and cited opportunities for funding partnerships with non-City agencies on some projects. Mr. Loughmiller thanked the participants of the Committee members and Trevor Minyard for his work in support of the Committee.

City Manager Grimes identified important action dates on the Bond Election timeline:

- February 5 City Council will make final determination of Bond propositions and totals, and call for May 2019 Bond Election
- February through May Community meetings, advocacy and media engagement to broaden awareness of Bond
- May 4 Election Day

Conduct a Public Hearing to Consider/Discuss/Act on a Specific Use 0013SUP2 Permit (SUP) Request for a Car Wash and Automotive Repair Facility, Located Approximately 600 Feet South of Virginia Parkway and on the West Side of Custer Road; and Accompanying Ordinance. Director Planning Jennifer Arnold stated in addition to the Car Wash and Automotive Repair Facility SUP, the applicant also requested to use living plant screens in lieu of masonry wall screening to hide the facility bay doors from public rights-of-way view. The request for the 2-acre site received a favorable recommendation from City Staff and the Planning and Zoning Commission in December 2018.

> Applicant Binson Ly, 8716 Denstone Drive, McKinney 75070, thanked Council for consideration of the requesting, stating he and his family are small business owners and residents of McKinney seeking to invest and be part of the community through the operation of their business as well as possible fund raising and charity initiatives to give back to the community. Vincent Jarrard, architect for the project was present in support of the item but did not speak. Council unanimously approved the motion by Council Member Elliott, seconded by Council Member Rogers, to close the Public Hearing and approved the Specific Use Permit Request for a Car Wash and Automotive Repair Facility, Located Approximately 600 Feet South of Virginia Parkway and on the West Side of Custer Road; and Accompanying Ordinance. Shiloh Road, Garland, TX 75042, civil engineer for the project stated the restaurant occupant for the drive-through site has not yet been determined and retail and/or restaurants are being considered for the site in addition to the drive-through. Council unanimously approved the motion by Mayor Pro Tem Rath, seconded by Council Member Elliott, to close the Public Hearing and approve the Specific Use Permit Request for a Restaurant with Drive-Through Window (Virginia Heights), Located Approximately 200 Feet North of Virginia Parkway and on the East Side of Coit Road and Accompanying Ordinance. Phases one and two are planned to connect the entire property as an industrial business park. Council unanimously approved the motion by Council Member Branch, seconded by Council Member Shemwell, to close the Public Hearing and approve the Request to Rezone the Subject Property from "AG" - Agriculture District to "LI" - Light Industrial District, Located at the Northeast Corner of Couch Drive and FM 546 (Harry McKillop Boulevard), and Accompanying Ordinance. Mr. Holloway thanked the Financial Services department, financial advisors, and bond counsel for the time and work involved. Bank of Texas was selected for the placement of the 10-year notes for favorable interest rate (3.9%) on the taxable notes. The principal and interest payments will be funded by the

lease payments on the facility. Council unanimously approved the motion by Council Member Branch, seconded by Council Member Elliott, to approve All Matters Incident and Related to the Issuance and Sale of "City of McKinney, Texas, Tax and Limited Pledge Waterworks and Sewer System Revenue Certificates of Obligation, Taxable Series 2019", Including the Adoption of an Ordinance Authorizing the Issuance of Such Certificates of Obligation, Establishing Parameters for the Sale and Issuance of Such Certificates of Obligation. Consider/Discuss/Act on a Resolution Authorizing the City Manager to Execute a Contract and All Necessary Change Orders with Blue Star Utilities, LLC for the construction of the WW4213 - Stover Creek Sanitary Sewer Project. Assistant Director of Engineering Michael Hebert stated the project is a partnership between the City of McKinney and developer HRC WCP Partners, LP to build infrastructure to serve over 1,600 acres of land within the City limits. Blue Star Utilities was the lowest bidder for the project and selected December 2018. The City's contribution to the project is capped at \$1.24 million. The developer is assisting with the management of the project and will manage any change orders. Council unanimously approved the motion by Mayor Pro Tem Rath, seconded by Council Member Elliott, to approve the Resolution Authorizing the City

Manager to Execute a Contract and All Necessary Change Orders with Blue Star Utilities, LLC for the construction of the WW4213 - Stover Creek Sanitary Sewer Project. Resolution caption reads as follows:

The appointment for Mr. Franklin will expire September 30, 2020. Council Member Branch recommended Bry Taylor to fill the Alternate seat with the term expiring September 30, 2019. Council unanimously approved the motion by Council Member Philips, seconded by Council Member Branch, to Appointment of New Members Rick Franklin and Bry Taylor (Alternate) to the Planning & Zoning Commission.

Mayor Fuller called again for Citizen Comments at which time there were no requests to speak.

Mayor Fuller called for Council and Manager Comments.

Council Member Philips thanked the members of the Bond Committee members for their service, noting the community involvement is a good reflection on the City and everyone he invited to participate did so with eagerness to help.

Council Member Rogers announced his intent to run for re-election for District 2 City Council, noting the decision came after careful consideration and discussion with his wife and reflection on the enjoyment of service on the Council as well as the good direction of the Council and leadership of Mayor Fuller.
