

CITY COUNCIL REGULAR MEETING

JUNE 4, 2019

The City Council of the City of McKinney, Texas met in regular session in the McKinney City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on June 4, 2019 at 6:00 p.m.

Council Present: Mayor George C. Fuller, and Council Members Charlie Philips, Scott Elliott, La'Shadion Shemwell, Frederick Frazier, and Rainey Rogers.

Council Member Richard Franklin was absent.

Mayor Fuller called the meeting to order at 6:02 p.m. upon determining a quorum of the Council was present, then called for the Invocation and Pledge of Allegiance.

The Invocation led by Deborah Bradford, Associate Pastor of New Jerusalem Church of McKinney. The Pledge of Allegiance led by Youth Members of New Jerusalem Church of McKinney.

Mayor Fuller called for Citizen Comments.

TJ Lane, 503 N Kentucky Street, McKinney, Texas, spoke to address his concerns about airport safety hazards and the potential harm to nearby residents.

Paul Ballesteros, 6508 Marvin Gardens, McKinney, Texas spoke in regard to homelessness in McKinney and the work and progress of his non-profit organization, Emmanuel Labor, which serves homeless individuals.

Council Member Rainey Rogers, along with fellow members of the Church of Jesus Christ of Latter-Day Saints, Todd Richardson and Jenny Chan, presented to Mayor Fuller a book of genealogy. The book was organized by the Church genealogy department and traced several generations of Mayor Fuller's family. Mayor Fuller accepted the book and expressed appreciation to Council Member Rogers and the guests. Mr. Rogers stated the Church understands the importance of family and heritage, with compilations of worldwide genealogy records, adding the Genealogy Center at the Eldorado Chapel is open most days to anyone to visit and research their ancestors.

Mayor Fuller called for the following items:

Council unanimously approved the motion by Mayor Fuller, seconded by Council Member Shemwell, to Elect Council Member Rainey Roger as Mayor Pro Tem. Mr. Rogers will serve in the role for a term of one year, until the next election of a Mayor Pro Tem at the first City Council meeting of June 2020.

Director of Planning Jennifer Arnold stated two other related items were on the agenda, requesting the Council to consider them individually. Director Arnold said the property is approximately two acres, and staff supports the request.

The applicant, Kevin MacIntosh, 704 Lindsay Way, Colleyville, Texas, stated the ownership group owns a combined twelve acres and intends to have the total area zoned alike, and plans to do a Phase 1 retail project that will include a Valvoline, Jason's Deli, and a couple of shopping strips on the west side of the property. The second phase will be to develop the east side of the property.

Planning Director Jennifer Arnold stated the item was companion item to the previous item **#18-0096Z2** concerning the same piece of property, to consider an auto-related facility (Valvoline). Staff has reviewed and supports the SUP and variance request for the screening of bay doors, which is typical.

Kevin MacIntosh, Applicant stated plans for the site included demolishing some of the existing facilities to construct the Valvoline facility. Council unanimously approved the motion by Council Member Shemwell, seconded by Council Member Elliott, to close the public hearing and approve a Specific Use Permit to Allow for Automotive Repair and Service Uses (Valvoline), Located Approximately 415 Feet West of Walnut Grove Road and on the North Side of U.S. Highway 380 (University Drive), and Accompanying Ordinance. Capital Improvements Project Manager Nick Ataie stated Archer Western Construction submitted the lowest base bid of the four received and scored highest on the evaluations and recommendation letters included in the submittal. If approved, construction would begin June 2019 and conclude October 2020. Council unanimously approved the motion by Council Member Elliott, seconded by Council Member Philips, to approve a Resolution Authorizing the City Manager to Execute a Contract and All Necessary Change Orders with Archer Western Construction, LLC for the Construction of the University Pump Station - 920 PP Pump No. 8 Project (WA1625). Resolution caption reads as follows:

Director of Engineering Gary Graham stated a small portion of land (0.129 acres or right-of-way and 0.02 acres of slope easement and drainage) is to be developed by the city for roadways; however, current ownership of the property is in dispute through litigation. Director Graham requested to utilize eminent domain allowing the city to pay the court for the property and move forward with the project. The court will then determine ownership and how compensation should be awarded for the city's purchase.

Council unanimously approved by roll call with assenting votes as follows, the motion by Mayor Pro Tem Rogers, seconded by Council Member Philips, to approved a Resolution Determining a Public Necessity to Acquire Certain Property for Public Use by Eminent Domain for Right-of-Way (in Fee Simple), Slope Easements and Drainage Easements for the Construction, Access and Maintenance Associated with a Roadway Infrastructure Project Along Country Lane from its Intersection with FM 546 to the Existing Concrete Pavement for Country Lane and Authorizing the City Manager to Establish Procedures for Acquiring the Right-of-Way (in Fee Simple) and Easements on Said Properties, and Take All Steps Necessary to Acquire the Needed Property Rights in Compliance with all Applicable Laws and Resolutions:

Mayor Fuller nominated Sally Huggins to be appointed to the board and fulfill the unexpired term of the departing Julie Baublis. Sally Huggins was previously a member of MCVB until 2018. Council Members Philips and Elliott, and Mayor Pro Tem Rogers also expressed support for the nominee. There were no other nominations.

Council unanimously approved the motion by Mayor Pro Tem Rogers, seconded by Council Member Philips, to appoint Sally Hugging to the McKinney Convention and Visitors Bureau, effective this date to September 30, 2019. Ms. Huggins will be eligible for reappointment to serve on city Boards & Commissions in 2019, 2021 and 2023 at the discretion of City Council.

19-0472 Consider/Discuss/Act on Appointing a Member to the McKinney Economic Development Corporation (MEDC).

Mayor Fuller nominated Tracy Rath to be appointed to the board and fulfill the unexpired term of the departing Paul Merritt. Tracy Rath served as a liaison the MEDC while a member of the City Council, was an avid participant in MEDC activities, is knowledgeable of current projects, and has served McKinney above and beyond

probably anyone to date. Council Elliott expressed strong support of the nominee noting her community perspective and ability to immediately support of the current direction and progress of the board. Council Member Shemwell, without specific opposition to the nominee or her credentials, encouraged the Council to consider other applicants for the seat and provide opportunity for new participants, voices and ideas. Mr. Shemwell stated former Council Member would always have the advantage when being considered for boards. Council Member Frazier expressed support for the nominee based on institutional knowledge, everything she has done in McKinney, and the ability to keep the momentum moving forward. There were no other nominations.

Council approved the motion by Mayor Fuller, seconded by Mayor Pro Tem Rogers, to appoint Tracy Rath to the McKinney Economic Development Corporation, effective now until September 30, 2020, with a vote of 5 - 1, Council Member Shemwell voting no. Tracy Rath will be eligible for reappointment to city Boards & Commissions in 2020, 2022 and 2024 at the discretion of City Council.

Mark Houser was called to speak regarding Agenda Item **19-0470**, noting the requirement for Council to include specific language of the motion. Council amended the motion to approve the item to include specific language of the motion. Mayor Pro Tem Rogers' motion was amended as follows:

"I move that the City of McKinney, Texas, City Council approve this item as written and adopt the Resolution described in this agenda item and authorize the use of the power of eminent domain to acquire for public use all necessary right-of-way (in fee simple), slope easements and drainage easement from the owner of the property depicted on and described by metes and bounds attached to said Resolution, said depictions and descriptions being incorporated in their entirety into this motion for all purposes including the construction, access and maintenance of infrastructure improvements along Country Lane from its intersection with FM 546 to the existing concrete pavement for Country Lane associated with the Roadway Infrastructure Project."

Council restated the roll call vote as previous, approving the item.

Mayor Fuller called again for Citizen Comments, of which there were none.

Mayor Fuller called for Council and Manager Comments.

Council Member Philips recognized the McKinney Education Foundation for their “outstanding” work in providing scholarships to McKinney students every year.

Council Member Elliott re-addressed the appointment of Tracy Rath to the MEDC, noting the present critical juncture of development in McKinney and her value of serving in this moment. Mr. Elliott also expressed understanding with Council Member Shemwell’s comments about involving for people and Council should consider that during the upcoming appointments in August 2019. Mr. Elliott stated the deadline for individuals to apply for Boards & Commissions is June 30, 2019, adding applicants should only list the boards they are truly interested in serving.

Mayor Pro Tem Rogers also recognized McKinney Education Foundation. The Mayor Pro Tem stated he had lunch with a graduate and MEF scholarship recipient, adding it will make a difference in her college. The Mayor Pro Tem recognized the Project Graduation event for high school seniors, to create a safe, overnight event to celebrate graduate, with many activities including money giveaways. Mayor Pro Tem Rogers acknowledged the benevolence of Eldorado Chevrolet for donating a prize car to the event, which his daughter won.

Council Member Shemwell commented on the latest city election, which lowered the number of petition signatures required for recall (of a Council Member). Council Member Shemwell stated recent activity has focused on attempting to recall him from his seat and encouraged residents to attend City Council meetings (and bring children and neighbors) to learn and hold people accountable; stated he realized that politics is not ugly or nasty, but ugly, nasty people sometimes come into politics, thus giving it such a reputation. Council Member Shemwell asked, “if recycling the same people and putting the same people on boards isn’t the good old boys club...what do you call it?” Council Member Shemwell expressed thanks for the opportunity to speak on Council, which he earned “by knocking on doors for six months and getting elected.”

Council Member Frazier expressed thanks for the opportunity to serve in McKinney stating he will serve in the best way he can. Council Member Frazier stated though he does not work in McKinney, his has not retired from law enforcement as some have rumored.

City Manager Paul Grimes welcomed Council Member Frazier; stated the Serve McKinney volunteer information event will be June 6, 2019, where citizens can learn about 100 non-profit boards and commissions and local organizations that need volunteer help; the Public Library summer reading program for children and teens will be June 6 to August 10; readers can earn prizes for finishing the program; the McKinney police and fire departments will host the “Battle of the Badges” blood drive June 7-9, 2019; blood donors can cast a vote in support of the fire or police department and receive an exclusive “Battle of the Badges” t-shirt. Mr. Grimes congratulated the city Communications & Marketing department for the *Discover McKinney* program on McKinney TV, which won the bronze award in the social video travel and tourism category at the 40th Annual Telly Awards (honoring excellence in television). *Discover McKinney* tied with MGM Resorts based on the Bellagio Fountains, and fared well against well-known big budget productions, such as Vice, Vimeo, Buzz Feed, Netflix, Radical Media, and A&E.

Mayor Fuller encouraged citizens to be engaged and look at the actions of all Council Members, not just in meetings but everyday as the elected people represent the City of McKinney. Mayor Fuller bid a final farewell to Former Mayor Pro Tem Tracy Rath thanking her for her service to the city on while on the Council, stating he was elated that she will be serving on the MEDC. Mayor Fuller again congratulated Mayor Pro Tem Rogers and Council Members Frazier and Franklin on their election victories.

There was no Executive Session. Council unanimously approved the motion by Council Member Shemwell, seconded by Mayor Pro Tem Rogers, to adjourn. Mayor Fuller adjourned the meeting at 6:57 p.m.
