The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, September 3, 2019, at 6:00 p.m.

Mayor Fuller called the meeting to order at 6:00 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance.

Mayor Fuller called for Information Sharing items.

Mayor Fuller read the proclamation for National Senior Center Month, acknowledging the value of the McKinney Senior Recreation Center and its 17-year history of providing activities and services to senior members. Recreation Coordinator Jessica Crouch commented of the upcoming week of activities to celebrate Senior Recreation. Mayor Fuller stood with Parks & Recreation Staff for photographs.

Mayor Fuller called for Citizen Comments.

Mayor Fuller called for the following Regular Agenda and Public Hearing items:

19-0738 Conduct Second Public Hearing on Proposed Tax Rate for Fiscal Year

2019-20 (Tax Year 2019). Chief Financial Officer Mark Holloway presented information at the second of two state-mandated public hearings regarding the proposed tax rate (the first of which was conducted August 20, 2019): the proposed tax rate is \$0.515600 based on 100% market ratio on each \$100 of all taxable property within the City, and the proposed tax rate is 0.009570 cents lower than last year. The rate for Maintenance and Operations (M&O) is \$0.355393 per \$100 valuation, and the rate for Interest and Sinking Funds (I&S) is \$0.160207 per \$100 valuation. The tax rate ratio is 69% for M&O and 31% for I&S. proposed tax rate exceeds the effective tax rate of \$0.508664. The proposed tax rate will raise more taxes for M&O than last year's tax rate. The amount of taxes imposed this year on the average home value of \$349,567 would be \$1,802. The tax rate adoption date is September 17, 2019, at which time at least 60 percent of the Council must vote in favor of the adoption ordinance. There were no requests by the public to speak at the Public Hearing. Council unanimously approved the motion by Council Member Franklin, seconded by Council Member Frazier, to close the Second Public Hearing on Proposed Tax Rate for Fiscal Year 2019-20 (Tax Year 2019).

Conduct First Public Hearing on the Budget Appropriation Ordinance for FY 2019-20. Chief Financial Officer Mark Holloway presented information regarding the Budget Appropriation: the proposed budget for all operating funds and CIP projects for FY 2019-20 total \$585.8 million; the proposed budget for component unit funds for FY2019-20 are McKinney Convention & Visitors Bureau \$863,815; McKinney Economic Development Corporation Debt Service Fund \$3,955,988; McKinney Economic Development Corporation \$15,029,119; McKinney Community Development Corporation \$10,338,530. The proposed tax rate is \$0.51560 per \$100 of assessed value. The second public hearing for the budget appropriation will be September 17, 2019,

followed by a vote to adopt the related ordinance. There were no public requests to speak on the Public Hearing. Council unanimously approved the motion by Council Member Philips, seconded by Council Member Frazier, to close the First Public Hearing on the Budget Appropriation Ordinance for FY 2019-20.

Conduct a Public Hearing to Consider/Discuss/Act on a Signage Meritorious Exception Request for Cultural District Identification Signs. Director of McKinney Performing Arts Center & McKinney Main Street Amy Rosenthal presented information regarding the request for Cultural District signage: Downtown McKinney was designated a Cultural District by the Texas Commission on the Arts (TCA) in November 2018. TCA provides cultural districts with unique funding opportunities, only available to designated districts. McKinney Main Street, a private 501(c)3, has received funding support from Texas Commission on the Arts and McKinney Community Development Corporation to manufacture and install three signature signs to help brand and identify the district, to create a unique attraction and to support evening activities. The signs include a pole sign, a blade sign and a roof-mounted sign. The pole sign will be installed at the corner of Virginia Street and Church Street. The blade sign will be installed on the west side of the Chestnut Commons parking structure, Chestnut Street. The roof-mounted sign will be installed on the parking structure to capture high visibility of Highway 5 traffic. Though these signs serve special purpose to help brand and identify the Historic Downtown McKinney Cultural District, they do not comply with city sign ordinances; therefor, McKinney Main Street requests a Meritorious Exception to the ordinance for the installation of three Cultural District identification signs. Staff has no objection to the request. The City of McKinney has not received a similar request for this type of signage. Most signage requests relate to a specific business - not a district. Similar district branding signs are found in Deep Ellum (Dallas,

Texas) and Red River Cultural District (Austin, Texas). The following citizen spoke in support of the request for a Meritorious Exception to allow the Cultural District signage:

emphasizing the need to remain aware of it.

City Manager Grimes stated the city deployed two paramedics Duke

Durham and Chris Harlow on August 24, to offer aid to the Texas Intrastate Fire

Mutual Aid System to assist efforts against Copper Breaks and Vivian wildfires.

Mr. Grimes thanked the two who have since returned to McKinney safely. Mr,

Grimes noted the Prepare-A-Thon campaign which encourages residents to

prepare for emergency situations. The Office of Emergency Management

System will be giving away 700 free emergency preparedness bags, which

include ice scrapers, rain gauges, and a variety of preparedness information.

The bags can be picked up from either of McKinney's two libraries in the month

of September. Additional information can be found on the city website.

Council did not meet in Executive Session.

Council Member Shemwell, to adjourn the meeting. Mayor Fuller adjourned the

meeting at 6:46 p.m.
