CITY COUNCIL REGULAR MEETING

SEPTEMBER 17, 2019

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, September 17, 2019 at 6:00 p.m.

There were approximately 60 guests present.

Mayor Fuller called the meeting to order at 6:00 p.m. upon determining a quorum of the Council was present.

Mayor Fuller called for the Invocation and recital of the Pledge of Allegiance.

Mayor Fuller called for Council and Manager Comments.

Council Member La'Shadion Shemwell expressed concern with the criminal justice system and the sense of double jeopardy regarding the treatment and experiences of individuals with criminal history after serving their sentence; and support of Brian O'Neil seeking legal remedies regarding the specific matter of his case. Mr.

Shemwell encouraged the public to have conversations in communities and social media about gun safety and not wait on government action. Mr. Shemwell stated he was an advocate for understanding the risks associated with 5G technology. Mr. Shemwell expressed understanding about the concerns regarding the homelessness resource center no matter where it will be located, similarly to past concerns for programs such as the Samaritan Inn shelter, which is now a great resource for the city.

Council Member Richard Franklin expressed support for the need for gun safety education and the opportunity for communities to take part in awareness. Mr. Franklin stated he was a bigger supporter of the Samaritan Inn and is passionate about identifying the right solution and location for providing resources for the homeless.

Council Member Frederick Frazier said he needed more education regarding 5G and expressed support for gun safety education and shared the Chief of Police spent time addressing youth and parents who were affected by a recent shooting. Mr. Frazier supported the temporary use of the library as a homelessness resource center until a permanent solution.

Mayor Fuller stated the library was one of multiple potential locations for a homelessness resource center. Mayor Fuller expressed support for gun safety education and desire for the Council to take a lead in discussing possible action.

Mayor Fuller made a motioned to discuss gun safety and education at the next City Council Work Session to be held on October 1, 2019. Council Member Shemwell seconded the motion, and Council reached consensus with no objections.

Mayor Fuller thanked the vocal citizens who expressed concern about 5G.

Council Member Charlie Philips recognized the McKinney resident youth attending schools in the Frisco Independent School District, he and congratulated the football victory by Frisco Lone Star High School, who defeated Highland Park. It was the first home loss for Highland Park in 21 years.

Council Member Scott Elliott expressed agreement with the previous comments by other members regarding the need for gun safety awareness and support for the need to help "our homeless neighbors" and those who are near being homeless. Mr. Elliott stated he would be seeking an opportunity to discuss 5G technology at a future work session.

Chief Financial Officer Mark Holloway presented information about the property tax revenues, stating the city's fiscal year 2019-20 Budget has an increase in property tax revenues as compared to the previous year. As a result of the approval of the Fiscal Year 2019-20 Budget, the City Council must ratify the increased revenue from property taxes. Council unanimously approved the motion by Council Member Philips, seconded by Mayor Pro Tem Rogers, to Ratify the Property Tax Revenue Increase in the Fiscal Year 2019-20 Budget as a Result of the City Receiving More Revenues from Property Taxes than the Previous Fiscal Year. Council Member Philips' motion was stated:

"I motion to ratify the property tax revenue increase in the fiscal year 2019-20 as a result of the city receiving more revenues from property taxes than the previous fiscal year. This budget will raise more total property taxes than last year's budget by \$5,116,760 or 4.43%, and of that amount, \$5,225,834 is tax revenue to be raised from new property added to the tax roll this year."

This data is then spatially allocated into the designated service areas.
