The city is currently in a lease agreement with the property owner and making monthly rental payments. The agreement includes an option to purchase the parking garage early. By doing so, the city will save approximately five hundred thirty-five thousand (535,000) dollars in insurance and interest costs that would accrue over the life of the lease. The brief sundown program will include a reading of the names on the Wall of Honor and the playing of "Taps." Mr. Grimes stated reserved tickets are on sale for twenty (20) dollars, and fifteen (15) dollar general admission tickets for the Division 2 Collegiate National Football Game. Ticket prices will increase on December 9. The game will be held on December 21.
