Council Member Scott Elliott recused himself from this item, stepping away from the meeting at 6:28 p.m. and returning at 6:41 p.m. after the vote to close the public hearing.

City Attorney Mark Houser presented information regarding the preliminary investigation of a complaint filed against Council Member La'Shadion Shemwell. Mr.

Houser stated the submittal met the criteria to be defined as a complaint but does not specify whether the complaint has merit. Mr. Houser stated the task of Council is to determine whether to dismiss the complaint or move forward with a more thorough investigation to determine if a civil violation may have occurred.

Council unanimously approved the motion by Mayor George Fuller, seconded by Mayor Pro Tem Rainey Rogers, to further investigate the complaint.

Mayor Fuller called for Council and Manager Comments.

Council Member La'Shadion Shemwell stated there was a Town Hall on Monday, December 16, 2019, to allow an opportunity to have open dialogue with the community which consisted of "good conversation" though not all in agreement. Mr. Shemwell stated some problems exist in the city, noting comments from social media and two police-involved incidents from 2015 and 2019. Mr. Shemwell stated the officers who know him would say he has never disrespected them. Mr. Shemwell left the meeting at 8:57 p.m. and did not return.

Council Member Richard Franklin commented on the recent Christmas parade and expressed excitement and pride to be able to participate and see the crowd. Mr. Franklin commended and thanked the staff and Main Street board for making the parade possible.

Council Member Frederick Frazier asked the audience to use appropriate language when making public comments and to refrain from using curse words in consideration of young people who are in attendance. Mr. Frazier commended the quality of the parade, stating the eighty-six (86) floats were the most ever and complimented to partnerships of the community groups to make the parade happen. Mr. Frazier stated that Officer Chad Hoya was a participate in the parade with him. Officer Hoya was involved in a vehicle accident while on duty the day before. Mr.

Frazier said the Wonder Special Event by Apex Centre would be happening over the weekend at Gabe Nesbitt Park, and wished the public a happy holiday season.

Council Member Charlie Philips thanked the Fire Department for the opportunity to ride in 1924 fire engine in the holiday parade. The Historic Preservation Advisory Board has published its annual calendar of historic McKinney homes, which is available free to the public. Mr. Philips commended McKinney Independent School District and Athletic Director Shawn Pratt for securing regional final and state semi-final football games in the 6A Division. McKinney competed with area facilities including facilities in Frisco, TX which are owned by Dallas Cowboys owner Jerry Jones. Additionally, the upcoming Division II Football Championship game will be held Saturday, December 21.

Council Member Scott Elliott stated that he rejects the notion that city, county and school board are conspiring to kill people of color, noting that as some citizens do not feel safe, addition conversation is needed. Mr. Elliott said he looked forward to listening, learning and helping in any way he can. Mr. Elliott stated that he will not campaign for or against candidates while serving on the Council, will work with Council and city staff. Mr. Elliott thanked the city staff for their work and encouraged them to continue the work of getting better and noting process improvement implementation and building renovation projects. Mr. Elliott offered advice for delivering constructive criticism: praise in public and correct in private, and criticize the action – not the person. Mr. Elliott stated the parade entries sold out two weeks before the deadline.

Mayor Pro Tem Rainey Rogers stated he attended the Town Hall meeting on December 16 and Council Member Shemwell said several things that were not accurate. Mayor Pro Tem Rogers expressed disappointment in comments regarding potential future protests at the Mayor's home.

Mayor Fuller stated comments made at the Town Hall meeting regarding water ratings were incorrect, and refuted Mr. Shemwell's comment regarding respecting Police.

Mr. Shemwell expressed disagreement with Mayor Fuller and Mayor Pro Tem Rogers then left the meeting at 8:57 p.m. not returning.

City Manager Paul Grimes invited the community to a "fanfest" event on Friday, December 20 ahead of the Division II Football Championship game on Saturday, CITY COUNCIL MINUTES DECEMBER 17, 2019 PAGE 10

December 21. The event is intended to welcome the visiting guests and teams. Mr. Grimes stated some City facilities and services would be closed during the holiday with information available online at the city website. The John & Judy Gay Library will be closed for a week in January for expansion construction, reopening January 13, 2020. Mr. Grimes wished everyone a happy holiday and stated the next City Council meeting will be January 7, 2020.

Council unanimously approved the motion by Mayor George Fuller, seconded by Mayor Pro Tem Rainey Rogers, to Adjourn with a vote of 6-0, Council Member Shemwell being absent. Mayor Fuller adjourned the meeting at 9:00 p.m.
