CITY COUNCIL SPECIAL MEETING

AUGUST 29, 2011

The City Council of the City of McKinney, Texas met in special session in the Council Chambers of the Municipal Building on August 29, 2011 at 5:30 p.m.

Council Present: Mayor Brian Loughmiller, Mayor Pro-Tem Travis Ussery, Council members: Geralyn Kever, Don Day, Ray Ricchi, and Roger Harris. Absent: Council member David Brooks.

Staff Present: City Manager Jason Gray; Deputy City Manager Rick Chaffin; Deputy City Manager Joe Williams; City Attorney Mark Houser; City Secretary Sandy Hart; Assistant City Secretary Blanca Garcia; Assistant to the City Manager Aretha Harvey; Help Desk Technical Richard Sewell; Finance Director Rodney Rhoades; Communications and Media Manager Anna Clark; Airport Director Ken Wiegand; and Planning Director Jennifer Cox.

There were 26 guests present.

Mayor Loughmiller called the meeting to order at 5:35 p.m. after determining a quorum present.

Council member Ricchi stepped down from discussion agenda item 11-387.

11-387 Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on a Resolution Supporting an Alternate Redistricting Plan for Collin County. Mayor Loughmiller called for public comment. City Manager Gray stated that the proposed Collin County redistricting plan may impact the City of McKinney's representation on the Commissioner's Court. Mr. Gray presented an alternate map for the Council and public support to be presented to the Collin County Commissioner's Court on September 6th. Mayor Loughmiller stated that his issue with the proposed county redistricting plan is that there was no opportunity for public comments prior to their adoption. Mayor Loughmiller called for public comments.

> Ms. Jodi Ann LaFreniere, 2014 Hillcrest Court, McKinney stated that she contacted the County Commissioners last week on behalf of the Chamber to express concerns about the proposed map as well as the

process for approving the map. She stated that the map that was voted on by the County Commissioners was not available to the public prior to the meeting and their approval. Ms. LaFreniere stated that she does not feel that the proposed map that the County Commissioners voted on was in the best interest for representation for McKinney. She expressed her appreciation of the County leadership to identify some opportunities for discussion with the County Commissioners and also to provide a forum where public input as well as comments would be taken. Council unanimously approved the motion by Council member Kever, seconded by Mayor Pro-Tem Ussery, to approve the Resolution Supporting an Alternate Redistricting Plan for Collin County with the following changes: "Section 1. The Redistricting Plan entitled "Alternative Option", attached hereto as Exhibit A, is hereby submitted to the Commissioners' Court as an alternative to the Redistricting Plan entitled "Red Map" attached hereto as Exhibit B. Section 2. The City Council desires that the Commissioners' Court consider the "Alternative Option" or other alternative scenarios that more fairly and equitably preserve the rights and voting powers of the citizens of McKinney in electing County Commissioners as Collin County's final Redistricting Plan."
