CITY COUNCIL SPECIAL MEETING

AUGUST 16, 2010

The City Council of the City of McKinney, Texas met in special session in the Council Chambers of the Municipal Building on August 16, 2010 at 5:00 p.m.

Council Present: Mayor Brian Loughmiller, Mayor Pro-Tem Mayor Pro-Tem Huff,
Council members: Council member Brooks, Council member Ussery, Geralyn Kever,
Council member Day, and Council member Ricchi.

Staff Present: Interim City Manager Rick Chaffin; Deputy City Manager Jim Parrish; City Attorney Mark Houser; City Secretary Sandy Hart; Assistant to the City Manager Aretha Harvey; Communications and Media Manager Anna Folmnsbee; McKinney Community Development Corporation - Cindy Schneible and Connie Gibson; McKinney Economic Development Corporation - David Pitstick and Jim Young.

There were 24 guests present.

Mayor Loughmiller called the meeting to order at 5:08 p.m. after determining a quorum present.

Mayor Loughmiller recessed the meeting into executive session at 5:10 p.m. per Texas Government Code Section 551.071 (2) – Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed) and Section 551.071 (1) (A) – Litigation / Anticipated Litigation, as listed on the posted agenda. Mayor Loughmiller recessed to the open session at 5:32 p.m.

10-365 Mayor Loughmiller called for Discussion on City Council Communication Protocol (Council member Day) (5 minutes). Council member Day stated that he requested this item for discussion to obtain clarification on how much money is available to spend on economic development projects with our limited bonding capacity. "Before we move forward on any of these projects, we need to prioritize and discuss where and how much we are going to invest." Mr. Day stated that Liaisons are limited on what information they can provide in their Council update because many of the projects are only discussed in executive session. Mayor Loughmiller stated that some items cannot be discussed in open session that are

related to litigation and personnel items. Mr. Loughmiller suggested that a system be established that would enable the Council to discuss these items more openly. Our job, as Council, is to set policies and once they are set to communicate it to the boards. Council member Ricchi stated that he has previously suggested that the Council eliminate the Liaison position and have the board Chair or a staff member update the Council. Mr. Loughmiller suggested that the Council use the same protocol that is established for putting items on the agenda for directing the City Attorney to send out communications. Council member Brooks stated that due to public disclosure laws, we are restricted from emailing each other our opinions if it is related to legal issues. We need to understand as a Council, that is not appropriate and we need to make sure these conversations take place here in open forum. Interim City Manager Chaffin stated that a Governance Retreat is being planned at the Mayor's recommendation on how you as a body want to Govern. Mr. Chaffin stated that the retreat will be broken down into four areas: 1. How we do our business, 2. What is the overall strategic direction, 3. McKinney Economic Development Alliance update, and 4. Prioritization of projects. Mayor Loughmiller stated that regarding directing the City Attorney and the need for items to be handled through the City Attorney, that the Council follow the same protocol that is used for placing an item on the agenda. Council can send an email, without any substantive comment, and ask that the item be posted for either executive session or for an open meeting.
