CITY COUNCIL SPECIAL MEETING

May 20, 2013

The City Council of the City of McKinney, Texas met in special session in the Council Chambers of the Municipal Building on May 20, 2013 at 5:30 p.m.

Council Present: Mayor Brian Loughmiller, Mayor Pro-Tem Travis Ussery, Council members: David Brooks, Geralyn Kever, Don Day, Ray Ricchi, Roger Harris, and Council member elect Randy P. Pogue.

There were 17 guests present.

Mayor Loughmiller called the meeting to order at 5:30 p.m. after determining a quorum present.

Mayor Loughmiller recessed the meeting into executive session at 5:30 p.m. per Texas Government Code Section 551.071 (2). Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed), Section 551.074 Personnel Matters and Section 551.087 Discuss Economic Development Matter as listed on the posted agenda. Mayor Loughmiller recessed to the open session at 5:37 p.m.

13-475 Mayor Loughmiller called for Consideration/Discussion/Action on an Ordinance of the City Council of the City of McKinney, Texas, Certifying the Election Results for the May 11, 2013 General Election. City

Secretary Sandy Hart presented the final canvass results of the election held on May 11, 2013. The final results are for Mayor - Brian Loughmiller 2,498 votes, Derrick E. Johnson 279 votes, Council Member At-Large - Randall "Randy" Pogue 1,800 votes, J. Martin Sanchez 635 votes, Jeremiah J. Hammer 385 votes, Council Member District 1 - Don Day 228 votes, Council Member District 3 - Travis L. Ussery, Jr. 668 votes. Ms. Hart stated that Brian Loughmiller is elected as Mayor for a 4 year term, Randall P. Pogue is elected as Council Member At-Large for a 4 year term, Don J. Day is elected as Council Member District 1 for a 4 year term, and Travis L. Ussery Jr. is elected as Council Member District 3 for a 4 year term. Council unanimously approved the motion by Council member Brooks, seconded by Council member Harris, to approve an Ordinance Certifying the Election Results for the May 11, 2013 General Election. 13-476 Mayor Loughmiller called for Council and City Manager Comments.

Council member Harris stated that the citizens of McKinney have been fortunate to have had David Brooks represent them on the City Council. Mr. Harris stated that he has been fortunate to serve with him and that he respected him as an elected official as well as a business man. He is proud to say that he served with the honorable David Brooks and wished him best of luck on his future endeavors.

Council member Geralyn Kever gave a quote by Mark Alexander that said "Ultimately the effectiveness of a team is measured in two ways: the ability to get things done and the degree to which members feel committed to one another and the goals of the team." She thanked Mr. Brooks for making them a better team and that his contributions centered

upon issue focus and not personality focus. Ms. Kever that Mr. Brooks for helping his colleagues focus on their goals.

Council member Ricchi stated that he didn't know him that well until he joined them on Council and stated that he has a lot of respect and admiration on all those counts. He stated that no one can ever say that he didn't speak his mind, and stated that they can all say that they know exactly where he stands and why he stood there. He stated that Mr. Brooks not only served the community on Council but also on the school board, developed a business, land development in Adriatica and stated that it's not about what he said he would do but what he has actually done with class. Mr. Ricchi stated that he enjoyed the debates. He stated that he enjoyed serving on council with him and stated that he learned a lot from him and thanked him.

Council member Day stated that for the last four years he has served with David Brooks on this council and what he has come to admire about him is he has a belief system and is always consistent and stands up for what he believes. He has always tried to do what he thought was best for the community and he never worried if his decision would affect his re-election. Mr. Day stated that he admired and appreciated his service. Mayor Pro-Tem Ussery stated that he hasn't always agreed with Mr. Brooks and that a difference of opinions is what makes a city healthy. Mr. Ussery expressed his appreciation for the sincerity of his service and he wishes him nothing but the best in his future.

Mayor Loughmiller stated that he has served on the City Council with 15 different individuals and that while they all have different backgrounds it always comes back to a dynamic group that centers around making the best decisions for the City. He stated that no matter if people agreed with Mr. Brooks or not, Mr. Brooks felt that he was doing what was best for the community when he made a decision or voted in a certain way. Mayor Loughmiller stated that he brought a lot of experience to Council with his

background in corporate life and as a CEO of a bank. Most importantly, he demonstrated to his employees the importance of community involvement that it is not just enough to work in a city but you also need to give back and contribute. Mr. Loughmiller stated he appreciated working with him in the last 4 years.

City Manager Gray stated that he echoed all of Council's comments and would also like to say that Mr. Brooks is a true servant leader within this Council and the community. Mr. Gray stated that this Council and organization will miss him and the community will continue to strengthen because of the work that he has and will continue doing for McKinney.

Council member Brooks thanked staff for what they do, day in and day out. Council is aware that all the work does not happen on the dais but rather it is the hard work of Mr. Gray and the team of leaders. Mr. Brooks stated that comments from his colleagues have been very kind. He stated that they went through a world financial crisis and now the City is in a period where they are really looking into the future with tremendous opportunities and challenges in the days ahead. Mr. Brooks expressed his gratitude for the honor it has been to serve with each of them for the last 4 years. Mr. Brooks stated that it is always good to take a pause and look back to say it has been a great 4 years. He stated that he will continue his commitment to the citizens of McKinney by serving in other areas. Mr. Brooks stated that it has been a terrific honor and they have some very good work and that we should all be proud of our Council. Mr. Brooks closed with appreciation to Mr. Pogue. He stated that the future of a city is only as bright as the people that will step up and serve when someone needs to step aside. He stated that there will be turnover over the next few years as some of the Council members reach their term limit. He thanked Mr. Pogue and his wife for stepping up to serve on Council and it is very satisfying when you see an excellent city achieve its destiny and we are in an excellent city.
