Valek, a Petition to Annex Fewer than 127 Acres, Located on the North and South Sides of Wilmeth Road and on the East and West Sides of County Road 161 (Future Ridge Road) Together with the Adjacent and/or Abutting Segments of Wilmeth Road and Ridge Road as Required by State Law. Planning Director Michael Quint stated that the property owners are requesting to annex 127 acres into the City of McKinney. Mr. Quint stated that when considering annexation of a property, the City considers a number of factors which include current

that the applicant is requesting to zone the property with a combination of

office and single family residential as well as retail on the corner of future

Ridge Road and Wilmeth Road. Applicant, Mr. Brent Miller, stated he is

available for questions and there were none. Mayor Loughmiller called

Kever, to approve closing public hearing.
