## CITY COUNCIL SPECIAL MEETING

## **APRIL 28, 2014**

The City Council of the City of McKinney, Texas met in special session in the Council Chambers of the Municipal Building on April 28, 2014 at 5:30 p.m.

Council Present: Mayor Brian Loughmiller, Mayor Pro Tem Travis Ussery, Council members: Geralyn Kever, Don Day, Ray Ricchi, Roger Harris, and Randy P. Pogue.

Mayor Loughmiller called the meeting to order at 5:38 p.m. after determining a quorum was present.

## **14-420** Welcome New Corporate Partner to McKinney

Mayor Loughmiller and City Council members welcomed new Hisun Corporation representatives Jason Sun, President of Hisun Motors Corporation USA, Hanna You, Finance Manager, and King Dai, Vice President. Mr. Loughmiller welcomed and expressed his appreciation to Hisun for locating in McKinney. He stated that Hisun is the sixth largest provider of utility vehicles in the United States and Canada. They will be assembling and testing products here in McKinney. They have purchased the

Emerson Process Management facility in east McKinney. Mr. Sun spoke on behalf of Hisun USA. As a member of the City of McKinney, Hisun will contribute efforts to support the City and its activities and help the City of McKinney become the number one place to live in America. MEDC President Jim Wehmeier thanked the MEDC Board, City Council, and Abby Liu for helping to make this happen. Mr. Sun spoke on behalf of Hisun USA. Hisun is honored to become a part of the City. In 2006, the HISUN USA branch was founded with customer service and assembly areas. HISUN prides itself in supplying customers with quick parts shipments and expert technical assistance.

14-421 Mayor Loughmiller called for Consideration/Discussion/Action on a Sister City Relationship with Wenjiang China. MEDC President Jim Wehmeier stated that through the Mayor's International Committee, James Chen has spearheaded a Sister City relationship with mainland China. Wenjiang China has agreed and welcomes the opportunity to enter a Sister City opportunity with McKinney. Wenjiang has asked that Council formally accept them as a Sister City. They will visit our community this summer, sponsored by MEDC as a business exchange mission. At a future date, we will visit them and they will host us. Mayor Loughmiller: As we compete with neighboring cities for businesses nationally as well as internationally, this type of relationship will help us compete for international companies that look to relocate to our area. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to approve a Sister City Relationship with Wenjiang China.

Mayor Loughmiller called for discussion on the following items with no action taken:

Discuss the Proposed Revisions to the Drainage Policy. Assistant Director of Engineering Michael Hebert reported on the update to the proposed revisions to the Drainage Policy. Mr. Hebert presented a list of recommendations that Council had previously approved. Mr. Hebert stated that the current fees collected are allocated to personnel, materials

and contracted services. Mr. Hebert stated that there was significant impact to the fund this year with the clearing of debris out of the creeks after the ice storms. The new fees are projected to generate about \$1.1 million per year. The current fee is based on single-family living unit equivalent which is based on the impervious area of a single-family lot. It is \$2.75 per one SFLUE. The plan is to leave the SFLUE in place but charge more if there's more impervious area. For 2,000 square feet of impervious area, the rate will remain the same. Between 2,000 and 5,000 square feet, the fee will bump up to \$5.00 per month and if it is over 5,000 square feet, the fee will bump up to \$7.50 per month. Commercial properties would be assessed in the same manner except that here would be a cap of \$500 per month. Mr. Hebert stated that the committee came up with the three-tier structure. Councilmember Kever stated when looking at the three proposed tiers for fee structure, there is obviously no change for less than 2,000 square feet. The middle range has a potential for an 81%increase. The \$7.50 fee for greater than 3,500 square feet has a potential for a 172% increase. Council requested to see a comparison on the commercial side with Frisco, Plano and Allen, and the revenue generated in McKinney under the existing fee structure and the proposed compared to our neighbors.

Mayor Loughmiller called for Consideration and Discussion on Council Input to the Dallas Regional Mobility Coalition. Council member Kever stated that she has provided Council with a draft copy of priorities as a starting point for discussion this evening. The second request is for input on the Proposition 1 position. The Dallas Regional Mobility Coalition is to consider a resolution in support of Proposition 1 either at this coming meeting or shortly thereafter. Proposition 1 has to do with the allocation of funds for transportation including use of rainy day fund money, similar to what they did with Proposition 6 with the water. It sets a floor to the amount of money they pull out of the fund so that they do not pull out and

overabundance of dollars for transportation or water. Mayor Loughmiller

stated that to provide guidance to Council, he would be comfortable

taking a position that we support Proposition 1 provided that we have a

firm understanding how the funds are allocated and what the limitations

are. There is a way to communicate to both DRMC and our

representatives that there is a concern about supporting the use of rainy

day funds for transportation. Ms. Kever stated that she is also soliciting

input from Council on TxDOT's request for input on nine priority projects

through the DRMC. The only project in Collin County is US 75 north of

Melissa Road to the Grayson County line.
