CITY COUNCIL SPECIAL MEETING

AUGUST 28, 2017

The City Council of the City of McKinney, Texas met in special session in the Jack Hatchell Collin County Administration Building at 2300 Bloomdale Road, McKinney, Texas on August 28, 2017 at 5:00 p.m.

Council Present: Mayor George C. Fuller, Mayor Pro Tem Rainey Rogers, Council members: Chuck Branch, Scott Elliott, Charlie Philips, Tracy Rath, and La'Shadion Shemwell.

There were twelve guests present.

Mayor Fuller recessed the meeting into executive session at 5:02 p.m. per Texas Government Code Section 551.071 (2) Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed), Section 551.071 (A). Litigation / Anticipated Litigation, Section 551.072 Discuss Real Property, and Section 551.087 Discuss Economic Development Matters as listed on the posted agenda. Mayor Fuller recessed back into open session at 6:21 p.m.

17-853 Mayor Fuller called for Consideration/Discussion/Action on a Resolution Providing Direction to Staff Regarding Municipal Annexations in 2017.

Planning Manager Jennifer Arnold stated this item is to consider a municipal annexation approach for the City for the remainder of 2017 in light of changes to Section 42 of the Texas Local Government Code.

Mayor Pro Tem Rogers made a motion to give direction for staff to move forward with option D. Council member Philips stated that there are four

options presented for moving forward with annexations in the extraterritorial jurisdiction (ETJ). He noted that he has cautioned Council on moving forward in selecting one of these four options tonight and questioned the prudence of putting this before Council at this time. Mayor Pro Tem Rogers stated his motion stands. Council member Branch stated he would prefer to go with a volunteer route for annexations rather than the other options available. Council approved the motion by Mayor Pro Tem Rogers, seconded by Councilwoman Rath, to approve a Resolution Providing Direction to Staff Regarding Municipal Annexations in 2017 with Option D, with a vote of 5-2-0, Council members Branch and Philips voting against. Caption reads as follows:

Mayor Fuller called for Consideration/Discussion/Action on a Resolution Amending the Policy on Board and Commission Member Appointment and Eligibility. City Attorney Mark Houser stated the changes presented would change the length of terms for a majority of the boards from one year to two years. There are five boards that have remained at two years by statute or ordinance. This change would make uniformity of all boards to have two year terms. Mr. Houser noted that the term limits will also revert back to three two year terms. If this is approved, there will need to be an adjustment in the appointment process tonight in that Council will have to determine which members appointed will receive one year terms and which members will receive two year terms. This will stagger the terms and allow continuity on the board. City Secretary Sandy Hart stated the deadline for applications is the third Friday in June to allow staff time to prepare the materials and Council time to review the material before the interviews begin in mid-July. Councilwoman Rath stated she would like for Council to consider adding Parks, Recreation and Open

Space Advisory Board liaisons. Council unanimously approved the motion by Council member Branch, seconded by Council member Elliott, to approve a Resolution amending the Policy on Board and Commission Member Appointment and Eligibility with the change in Section II to add the addition of Liaisons to the Parks, Recreation, and Open Space Advisory Board. Mayor Fuller called for Consideration/Discussion/Action on 2017-18 Board and Commission Appointments, Including Removals Resulting from Such Appointments. City Attorney Houser stated this process has been in place for about ten years. Committees have conducted interviews and submitted a group of recommendations for appointment to the boards. Those names are listed for Council's consideration. Any Council member may add additional names to the list. Council will be given preference sheets to select the number of board members needed to fill any vacancies. Once the preferences are tallied, Council will vote on the board members with the most preferences. Once approval of the board is complete, Council will vote on which members will serve in the one year terms and which members will serve in the two year terms.
