unanimously approved the motion by Council member Day, seconded by Council member Brooks, to approve the Ordinance amending sections of Chapter 146 of the Code of Ordinances, as recommended by staff, subject to the additional request to staff to expeditiously review and develop standards for increasing building height requirements generally within 1,000 of a major corridor and grandfathering existing regulations for any projects that have a pending application and for any existing PD where prior multi-family uses were a specifically called out as allowed use rather than allowed within a base district.
