- 14-131 Update on US75 Construction. CIP Manager Gary Graham presented an update on the US75 Construction at the intersections of Valley Creek, Parkview, and US75. Mr. Graham discussed access to and from McKinney High School and the estimated US75 construction completion date of the end of 2015.
- 14-132 Update on Implementation of Middle School SROs. Police Sergeant David Rodriguez presented a new tip411 program that is an internet-based communication system that gives students or any concerned citizen a means to quickly and anonymously report suspicious or criminal behavior at school.

- 14-133 Update on Coordination of Two-Way Radio System. MISD Director of Safety, Security and Transportation Greg Hill provided an update on the two-way radio system throughout MISD.
- 14-134 Update on Coordinated City and District Efforts to Improve Sidewalks
 Consistent with Planned Campus Rezonings. City Manager Jason Gray
 provided an update on the coordinated efforts between the City of
 McKinney and MISD regarding sidewalks used by students to access
 schools. Mr. Gray stated that one sidewalk was brought to the City's
 attention along Mallard Lakes that will be installed to provide walking
 access to Boyd High School.
- 14-135 Update on Development Timeline within Trinity Falls MUD and Potential Impact on MISD. Executive Director of Development Services Barry Shelton provided an overview of the timeline for the construction of the Trinity Falls Municipal Utility District. The first planning unit will include 525 single family lots with the delivery of the first 33 is scheduled for March 2014 with the balance delivered between May and July. There is
