## **JOINT MEETING**

## **JUNE 22, 2015**

The City Council and the McKinney Community Development Corporation of the City of McKinney, Texas met in join session in the Council Chambers of the Municipal Building on June 22, 2015 at 5:30 p.m.

There were approximately 36 guests present.

Mayor Loughmiller called the City Council meeting to order at 5:30 p.m. after determining a quorum present.

Chairman Elliott called the McKinney Community Development Corporation to order at 5:31 p.m. after determining a quorum present.

15-613 Mayor Loughmiller and Chairman Elliott called for an update to City Council and McKinney Community Development Corporation for Consideration/Discussion/Action on a Contract for the Construction Manager at Risk (CMAR) Services with Manhattan Construction Company of Dallas, Texas for a Guaranteed Maximum Price (GMP) Related to the Construction of the Aquatics and Fitness Center Project Located at Gabe Nesbitt Community Park. Facilities Construction Manager Patricia Jackson presented the contract for the Construction

Manager at Risk (CMAR) Services with Manhattan Construction Company of Dallas, Texas for a Guaranteed Maximum Price (GMP) related to the construction of the Aquatics and Fitness Center Project located at Gabe Nesbitt Community Park. Ms. Jackson presented the current budget for the project that shows a total GMP amount of construction at \$30,251,359. Staff is requesting Council's consideration for an amount not to exceed \$30,450,000, with \$200,000 in owner's contingency for the project. Ms. Jackson stated that the construction contingency is 1.9% based on the cost of construction which seems appropriate. Changes made to get the project to stay within budget were decreases in glazing, increases in masonry and the height of the natatorium was lowered. Dwayne Brinkley, Brinkley Sargent Wiginton stated they were able to cut back on preparation of the site which saved on the budget. The appearance of the project did not change due as a result of any of the changes. McKinney Community Development Corporation Council unanimously approved the motion by Vice Chairman Kuehn, seconded by Board member Smith, to approve a Guaranteed Maximum Price Construction Contract for the Aquatics and Fitness Center Project, including a GMP amendment of \$30,450,000, and subject to review and approval of the contract form by MCDC legal counsel. Council unanimously approved the motion by Council member Pogue, seconded by Council member Harris, to approve the item as read by McKinney Community Development Corporation motion as well as presented by staff.

approval of a \$175,000 not to exceed amount for this contract. This item

is for McKinney Community Development Corporation approval only.

to approve the negotiation of the contract in the amount not to exceed

\$175,000 for materials testing services.
