Mr. Guthrey discussed the key partners working together on the Southgate project including the MEDC, MCDC, KDC, and Shaw Realty. Mr. Guthrey asked Frank Mihalopoulos to come up and speak about ATR Corinth. Mr. Mihalopoulos noted that while Southgate is

a great mixed use property, they have been waiting for a big corporate or relocation announcement to be the catalyst for the project. Mr. Shaw reiterated that KDC is the right partnership for Southgate. Mr. Shaw feels confident KDC is exposing the property.
