The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on December 17, 2018 at 5:30 p.m.

Mayor Fuller called for Council Liaison Updates.

Council Member Elliott recognized the Parks and Recreation Department and the Parks and Recreation Advisory Board for increased activity and improvements taking place within the department, noting he hears many compliments from McKinney residents who appreciate the services provided by Parks and Recreation.

Council Member Rogers acknowledged mistakenly referring to the annual downtown Christmas event by its former name "Dickens of a Christmas." Mr. Rainey stated he spoke previously of his disappointment for the event name changing to "Home for the Holidays" and the removal of the word "Christmas" from the name. Mr. Rogers said it was brought to his attention the new name is actually "Home for the Holidays McKinney Christmas" and apologized for the error. He also commended the staff who work on the event and expressed gratitude for keeping "Christmas" in the event name.

Council Member Shemwell mentioned the 70 year old "obsolete" McKinney Housing Authority buildings on Tennessee Street had been demolished, he was excited for more than 200 residents of the Housing Authority to have dignified housing with new buildings, and the it will spark new development in the area of Highway 380, Tennessee Street and Highway 5.

Mayor Pro Tem Rath mentioned the Main Street Board met the previous Thursday for an extensive debriefing of the Home for the Holidays event. The board is pleased overall with the event with only minor tweaks for the next year and is currently planning for the Arts in Bloom event scheduled for spring.

Mayor Fuller recognized McKinney ISD and Athletics Director Shawn Pratt for the successful presentation of the Division II National Football Championship event held the previous Saturday, as NCAA players and staff were very complimentary of the overall experience. Mayor Fuller said discussions are underway for possibly hosting the event again in the future.
