## **CITY COUNCIL WORK SESSION**

## **APRIL 16, 2019**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, April 16, 2019 at 3:00 p.m.

Council Present: Mayor Pro Tem Tracy Rath, and Council Members Scott Elliott, Rainey Rogers, and Chuck Branch.

Council Member La'Shadion Shemwell joined the meeting at 3:03 p.m. Mayor George C. Fuller joined the meeting at 3:56 p.m.

Mayor Pro Tem Rath called the meeting to order at 3:01 p.m. upon determining a quorum of the Council was present.

Mayor Pro Tem Rath called for Council Liaison Updates.

Council Member Scott Elliott recognized the Parks & Recreation department's applicant for grant funding to improve the tennis complex. The amount of the grant of approximately \$700,000 (seven hundred thousand) dollars will be supplemented with \$1,000,000 (one million) dollars in additional private funds. The MEDC hired a new staff member for Marketing.

Mayor Pro Tem Rath stated about the Main Street board there has been positive discussion regarding items scheduled to soon go before the City Council, and complimented Director Amy Rosenthal and staff of McKinney Performing Arts Center (MPAC) on "spectacular" presentation of the Arts in Bloom special event, despite inclement weather over the weekend. Staff member Aaron Werner recently attended a Main Street in Seattle, WA, and upon his return provided a detailed and enlightening presentation on new opportunities for the McKinney Main Street program.
