

CITY COUNCIL WORK SESSION

OCTOBER 1, 2019

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, October 1, 2019 at 3 p.m.
