Mayor Fuller called for Council Liaison Updates.

Council Member Philips the new calendar featuring homes of the Historic District has been released. The Library Board met for an update on the John & Judy Gay Library expansion project, which is progressing on schedule. Council Member Philips thanked the members who serve on the various boards and commissions.

Council Member Elliott commented on the grants application process currently taking place with the McKinney Community Development Corporation (MCDC), encouraging interested groups to apply for funding support. Information about the program is available on the MCDC website.

Council Member Shemwell stated Parks & Recreation has wonderful staff and boards members and encouraged the public to attend the upcoming holiday programs offered through the department. Proceeds of the Apex Centre Wonder event will benefit

Apex scholarships. Council Member Shemwell the North Central Texas Council of Governments (NCTCOG) 9-1-1 Board will hold its quarterly meeting on Thursday this week. Council Member expressed the Council's trust in the various board members to serve and deliver effect decision making on behalf of the citizens of the city.

Council Member Frazier commented on the Wonder special event offered by the Apex Centre Council. The Apex membership is growing with families and increased use of the children's area. Council Member Frazier stated the city's disc golf course, which recently had some equipment improvements sponsored in part by the regular users of the course, is the number one used disc golf course in the nation. Mr. Frazier complimented the MCDC grant programs and the Main Street Home for the Holidays event.
